3	SECTION 1. SHORT TITLE.
4	This Act may be cited as the "Safe Communities Act
5	of 2020".
6	SEC. 2. RESPONSIBILITIES OF CISA DIRECTOR RELATING
7	TO SECURITY RESOURCES CLEARINGHOUSE.
8	Subsection (c) of section 2202 of the Homeland Secu-
9	rity Act of 2002 (6 U.S.C. 652) is amended—
10	(1) by redesignating paragraphs (6) through

1	SEC. 3. STAKEHOLDER OUTREACH AND OPERATIONAL EN-

3	(a) Strategy.—Not later than 180 days after the
4	date of the enactment of this Act, the Director of the Cy-
5	bersecurity and Infrastructure Security Agency of the De-
6	partment of Homeland Security shall issue a strategy to
7	improve stakeholder outreach and operational engagement
8	that includes the Agency's strategic and operational goals
9	and priorities for carrying out stakeholder engagement ac-
10	tivities.
11	(b) CONTENTS.—The stakeholder outreach and oper-
12	ational engagement strategy issued under subsection (a)
13	shall include the following:
14	(1) A catalogue of the stakeholder engagement
15	activities and services delivered by protective security
16	advisors and cybersecurity advisors of the Cyberse-
17	curity and Infrastructure Security Agency of the De-
18	partment of Homeland Security, including the loca-
19	tions of the stakeholder engagement and services de-
20	livered and the critical infrastructure sectors (as

10	(4) A description of programs, policies, and ac-
11	tivities used to carry out such stakeholder engage-

15	erators and other entities, as appropriate, based on
16	current and projected demand for Agency services.

20	ticable, solicit input from stakeholders representing the

1	(d) Implementation Plan.—Not later than 90
2	days after issuing the stakeholder outreach and oper-
