17	SEC. 4. LOCAL LAW ENFORCEMENT SECURITY TRAINING.
18	(a) IN GENERAL.—The Secretary of Homeland Secu-
19	rity, in consultation with public and private sector stake-
20	holders, may develop, through the Federal Law Enforce-
21	ment Training Centers, a training program to enhance the
22	protection, preparedness, and response capabilities of law
23	enforcement agencies with respect to threats of terrorism
24	and other threats, including targeted violence, at a surface
25	transportation asset.

1	(b) REQUIREMENTS.—If the Secretary of Homeland
2	Security develops the training program described in sub-
3	section (a), such training program shall—
4	(1) be informed by current information regard-
5	ing tactics used by terrorists and others engaging in
6	targeted violence;
7	(2) include tactical instruction tailored to the
8	diverse nature of the surface transportation asset
9	operational environment; and
10	(3) prioritize training officers from law enforce-
11	ment agencies that are eligible for or receive grants
12	under sections 2003 or 2004 of the Homeland Secu-
13	rity Act of 2002 (6 U.S.C. 604 and 605) and offi-
14	cers employed by railroad carriers that operate pas-
15	senger service, including interstate passenger service.
