This Act may be cited as the "DHS Illicit Cross-Bor-

8 (a) Counter Illicit Cross-Border Tunnel Op-
9 ERATIONS STRATEGIC PLAN.—

1	(1) In general.—Not later than 180 days
2	after the date of the enactment of this Act, the
3	Commissioner of U.S. Customs and Border Protec-
4	tion shall develop a strategic plan to address the fol-
5	lowing:
6	(A) Risk-based criteria to be used to
7	prioritize the identification, breach, assessment,
8	and remediation of illicit cross-border tunnels.
9	(B) Promote the use of innovative tech-
10	nologies to identify, breach, assess, and reme-
11	diate illicit cross-border tunnels in a manner
12	that, among other considerations, reduces the
13	impact of such activities on surrounding com-
14	munities.
15	(C) Processes to share relevant illicit cross-
16	border tunnel location, operations, and technical
17	information.
18	(D) Indicators of specific types of illicit
19	cross-border tunnels found in each U.S. Border
20	Patrol sector identified through operations to be
21	periodically disseminated to U.S. Border Patrol
22	sector chiefs to educate field personnel.
23	(E) A counter illicit cross-border tunnel
24	operations resource needs assessment that in-
25	cludes consideration of the following:

1	(i) Technology needs.
2	(ii) Staffing needs, including the fol-
3	lowing:
4	(I) A position description for
5	counter illicit cross-border tunnel op-
6	erations personnel.
7	(II) Any specialized skills re-
8	quired of such personnel.
9	(III) The number of such full
10	time personnel, disaggregated by U.S.
11	Border Patrol sector.
12	(2) Report to congress on strategic
13	PLAN.—Not later than one year after the issuance of
14	the strategic plan required under paragraph (1), the
15	Commissioner of U.S. Customs and Border Protec-
16	tion shall submit to the Committee on Homeland Se-
17	curity of the House of Representatives and the Com-
18	mittee on Homeland Security and Governmental Af-
19	fairs of the Senate a report on the implementation
20	of paragraph (1).
21	(b) AUTHORIZATION OF APPROPRIATIONS.—There is
22	authorized to be appropriated to the Commissioner of U.S.
23	Customs and Border Protection \$1,000,000 for each of
24	fiscal years 2022 and 2023 to carry out remediation oper-
25	ations of illicit cross-border tunnels.
