1	SECTION 1. SHORT TITLE.
2	This Act may be cited as the "Decoupling from For-
3	eign Adversarial Battery Dependence Act".
4	SEC. 2. PROHIBITION ON AVAILABILITY OF FUNDS FOR
5	PROCUREMENT OF CERTAIN BATTERIES.
6	(a) In General.—Beginning on October 1, 2027,
7	none of the funds authorized to be appropriated or other-
8	wise made available for the Department of Homeland Se-
9	curity may be obligated to procure a battery produced by
10	an entity specified in subsection (b).
11	(b) Entities Specified.—The entities specified in
12	this subsection are the following:
13	(1) Contemporary Amperex Technology Com-
14	pany, Limited (also known as "CATL").
15	(2) BYD Company, Limited.
16	(3) Envision Energy, Limited.
17	(4) EVE Energy Company, Limited.

(5) Gotion High tech Company, Limited.

1	(6) Hithium Energy Storage Technology com-
2	pany, Limited.
3	(7) Any successor to an entity specified in para-
4	graphs (1) through (6).
5	(c) Treatment of Production.—For purposes of
6	this section, a battery shall be treated as produced by an
7	entity specified in subsection (b) if such entity—
8	(1) assembles or manufactures the final product
9	that uses such battery; or
10	(2) creates or otherwise provides a majority of
11	the components used in such battery.
12	(d) Waivers.—
13	(1) Relating to assessment.—The Secretary
14	of Homeland Security may waive the limitation
15	under subsection (a) if the Secretary assesses in the
16	affirmative all of the following:
17	(A) The batteries to be procured do not
18	pose a national security, data, or infrastructure
19	risk to the United States.
20	(B) The entity that produced such bat-
21	teries does not satisfy the criteria for listing
22	under—
23	(i) section 1260H of the National De-
24	fense Authorization Act for Fiscal Year
25	2021 (10 U.S.C. 113 note); or

1	(ii) Public Law 117–78 (commonly re-
2	ferred to as the "Uyghur Forced Labor
3	Prevention Act").
4	(C) There is no available alternative to
5	procure batteries that are—
6	(i) of similar or better cost and qual-
7	ity; and
8	(ii) produced by an entity not speci-
9	fied in subsection (b).
10	(2) Relating to research.—The Secretary
11	of Homeland Security may waive the limitation
12	under subsection (a) if the Secretary determines
13	that the batteries to be procured are for the sole
14	purpose of research, evaluation, training, testing, or
15	analysis
16	(3) Congressional notification.—Not later
17	than 15 days after granting a waiver under this sub-
18	section, the Secretary of Homeland Security shall
19	submit to the Committee on Homeland Security of
20	the House of Representatives and the Committee on
21	Homeland Security and Governmental Affairs of the
22	Senate a notification relating thereto.
