IN THE HOUSE OF REPRESENTATIVES

Ms. CLARKE of New York introduced the following bill; which was referred
to the Committee on Homeland Security

A BILL

To amend the Homeland Security Act of 2002 to establish
a DHS Cybersecurity Internship Program, and for other
purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “DHS Cybersecurity
5 Internship Program Act”.

1 **SEC. 2. DEPARTMENT OF HOMELAND SECURITY CYBERSE-**
2 **CURITY INTERNSHIP PROGRAM.”.**

3 (a) PROGRAM.—Subtitle D of title XIII of the Home-
4 land Security Act of 2002 is amended by adding at the
5 end the following new section:

6 **“SEC. 1334. CYBERSECURITY INTERNSHIP PROGRAM.**

7 “(a) PROGRAM.—The Secretary shall carry out a cy-
8 bersecurity internship program (in this section referred to
9 as the ‘Program’) under which an eligible individual par-
10 ticipates in a paid cybersecurity internship at the Depart-
11 ment with duties aligned to such participant’s respective
12 education, skills, and experience.

13 “(b) ELIGIBILITY.—To be eligible to participate in
14 the Program, an individual shall—

15 “(1) be a citizen of the United States;

16 “(2) be at least 16 years old; and

17 “(3) be enrolled in a secondary school, tech-
18 nical, trade, or vocational school, or institution of
19 higher education, in accordance with subsection (c).

20 “(c) COMPOSITION.—The Secretary shall, as prac-
21 ticable, ensure that participants selected for the Program
22 for each intern class include students enrolled in each of
23 the following:

24 “(1) Secondary schools.

25 “(2) Junior or community colleges.

26 “(3) Undergraduate degree programs.

1 “(4) Postgraduate degree programs.

2 “(5) Technical, trade, or vocational schools.

3 “(d) REPORTS.—

4 “(1) REPORTS.—Not later than one year after
5 the date of the enactment of this section and annu-
6 ally thereafter, the Secretary shall submit to the
7 Committee on Homeland Security of the House of
8 Representatives and the Committee on Homeland
9 Security and Governmental Affairs of the Senate a
10 report on the Program.

11 “(2) MATTERS.—Each report under paragraph
12 (1) shall include, with respect to the most recent
13 Program year, the following:

14 “(A) A description of outreach efforts by
15 the Secretary to raise awareness of the Pro-
16 gram among secondary schools and institutions
17 of higher education, including among junior or
18 community colleges, historically-Black colleges
19 and universities, and other minority-serving in-
20 stitutions.

21 “(B) Information on specific recruiting ef-
22 forts by the Secretary to increase participation
23 in the Program.

24 “(C) The number of individuals partici-
25 pating in the Program, listed by the type of

1 school or program in which the individual is en-
2 rolled at the time of participation, and informa-
3 tion on the nature of each such participation,
4 including Department components supported,
5 and the duties of each such individual.

6 “(3) CONSOLIDATION.—Reports submitted
7 under this subsection may be consolidated with the
8 reports required under section 1333(e).

9 “(e) DEFINITIONS.—In this section:

10 “(1) HISTORICALLY BLACK COLLEGE OR UNI-
11 VERSITY.—The term ‘historically Black college or
12 university’ has the meaning given the term ‘part B
13 institution’ in section 322 of the Higher Education
14 Act of 1965 (20 U.S.C. 1061).

15 “(2) INSTITUTION OF HIGHER EDUCATION.—
16 The term ‘institution of higher education’ has the
17 meaning given that term in section 101 of the High-
18 er Education Act of 1965 (20 U.S.C. 1001).

19 “(3) JUNIOR OR COMMUNITY COLLEGE.—The
20 term ‘junior or community college’ has the meaning
21 given that term in section 312 of the Higher Edu-
22 cation Act of 1965 (20 U.S.C. 1058).

23 “(4) MINORITY-SERVING INSTITUTION.—The
24 term ‘minority-serving institution’ means an eligible
25 institution of higher education described in section

1 371(a) of the Higher Education Act of 1965 (20
2 U.S.C. 1067q(a)).

3 “(5) SECONDARY SCHOOL.—The term ‘sec-
4 ondary school’ means a school or program that pro-
5 vides secondary education, as determined under
6 State law, except that the term does not include any
7 education beyond grade 12.

8 “(6) TECHNICAL, TRADE, OR VOCATIONAL
9 SCHOOL.—The term ‘technical, trade, or vocational
10 school’ has the meaning given that term in section
11 411.167 of title 20, Code of Federal Regulations.”.

12 (b) CLERICAL AMENDMENT.—The table of contents
13 in section 1(b) of the Homeland Security Act of 2002 is
14 amended by inserting after the item relating to section
15 1333 the following new item:

“Sec. 1334. Cybersecurity internship program.”.
