## SUBCOMMITTEE ACTION

The Subcommittee on Counterterrorism and Intelligence of the Committee on Homeland Security met, pursuant to notice, in open markup session, a quorum being present, on Thursday, May 18, 2017, in 210 of the House Visitors Center to consider the following measures:

- H.R. 2427, (Mrs. Demings) To amend the Homeland Security Act of 2002, to direct the Assistant Secretary for State and Local Law Enforcement to produce and disseminate an annual catalog on Department of Homeland Security training, publications, programs, and services for State, local, and tribal law enforcement agencies, and for other purposes. The "Pathways to Improving Homeland Security At the Local Level Act".
- H.R. 2433, (Miss Rice of New York) To direct the Under Secretary of Homeland Security for Intelligence and Analysis to develop and disseminate a threat assessment regarding terrorist use of virtual currency. The "Homeland Security Assessment of Terrorists Use of Virtual Currencies Act".
- H.R. 2442, (Ms. Jackson Lee) To amend the Homeland Security Act of 2002 to require an annual report on the Office for State and Local Law Enforcement. The "Federal Information Resource to Strengthen Ties with State and Local Law Enforcement Act of 2017".
- H.R. 2443, (Mr. Barletta) To require an inventory of all facilities certified by the Department of Homeland Security to host infrastructure or systems classified above the Secret level, and for other purposes. The "Department of Homeland Security Classified Facility Inventory Act".
- H.R. 2453, (Mr. Gallagher) To amend the Homeland Security Act of 2002 to establish the Intelligence Rotational Assignment Program in the Department of Homeland Security, and for other purposes. The "DHS Intelligence Rotational Assignment Program Act of 2017".
- H.R. 2454, (Mr. Hurd) To direct the Secretary of Homeland Security to establish a framework to provide access for appropriate personnel to intelligence information

of the Department, and for other purposes. The "Department of Homeland Security Data Framework Act of 2017".

- H.R. 2468, (Mr. Perry) To amend the Homeland Security Act of 2002 to establish a homeland intelligence doctrine for the Department of Homeland Security, and for other purposes. The "Unifying DHS Intelligence Enterprise Act".
- H.R. 2470, (Mr. Rogers of Alabama) To require an annual homeland threat assessment, and for other purposes. The "Homeland Threat Assessment Act".
- H.R. 2471, (Mr. Rutherford) To direct the Secretary of Homeland Security to share with State, local, and regional fusion centers release information from a Federal correctional facility, including name, charging date, and expected place and date of release, of certain individuals who may pose a terrorist threat, and for other purposes. The "Terrorist Release Announcements to Counter Extremist Recidivism Act".

The Committee took the following actions:

H.R. 2471, To direct the Secretary of Homeland Security to share with State, local, and regional fusion centers release information from a Federal correctional facility, including name, charging date, and expected place and date of release, of certain individuals who may pose a terrorist threat, and for other purposes.; was reported to the Full Committee with a favorable recommendation, without amendment, by voice vote.

The Subcommittee agreed to H.R. 2471 as amended, by voice vote.

The following amendment was offered:

An en bloc amendment offered by Miss Rice of New York (#1); consisting of the following amendments:
An amendment:
Page 2, line 7, insert "the Privacy Officer and the Officer for Civil Rights and Civil Liberties of the Department of the Department of Homeland Security" before "appropriate".
Page 2, beginning line 22, insert a new subsection entitled "(c) Privacy Impact Assessment."
An amendment:
Page 3, after line 5, add a new subsection entitled "(d) Rule of Construction."; was AGREED TO, by voice vote.

Without objection, staff are authorized to make technical and conforming corrections.

A unanimous consent request by Mr. King of New York to consider H.R 2443, H.R. 2433, H.R. 2468, H.R. 2442, H.R. 2454, H.R. 2427, H.R. 2453, and H.R. 2470 en bloc; was not objected to.

H.R. 2443, To require an inventory of all facilities certified by the Department of Homeland Security to host infrastructure or systems classified above the Secret level, and for other purposes.; was reported to the Full Committee with a favorable recommendation, as amended, by voice vote.

A unanimous consent request by Mr, King of New York to amend the short title so as to read "Homeland Security Assessment of Terrorists' Use of Virtual Currencies Act", was not objected to.

Without objection, staff are authorized to make technical and conforming corrections.

H.R. 2433, To direct the Under Secretary of Homeland Security for Intelligence and Analysis to develop and disseminate a threat assessment regarding terrorist use of virtual currency.; was reported to the Full Committee with a favorable recommendation, without amendment, by voice vote.

H.R. 2468, To amend the Homeland Security Act of 2002 to establish a homeland intelligence doctrine for the Department of Homeland Security, and for other purposes.; was reported to the Full Committee with a favorable recommendation, without amendment, by voice vote.

H.R. 2442, To amend the Homeland Security Act of 2002 to require an annual report on the Office for State and Local Law Enforcement.; was reported to the Full Committee with a favorable recommendation, without amendment, by voice vote.

A unanimous consent request by Mr. King of New York to amend the short title of the measure as noticed to conform with the measure as introduced so as to read "Federal Information Resource to Strengthen Ties with State and Local Law Enforcement Act of 2017", was not objected to.

H.R. 2454, To direct the Secretary of Homeland Security to establish a framework to provide access for appropriate personnel to intelligence information of the Department, and for other purposes.; was reported to the Full Committee with a favorable recommendation, without amendment, by voice vote.

H.R. 2427, To amend the Homeland Security Act of 2002, to direct the Assistant Secretary for State and Local Law Enforcement to produce and disseminate an annual catalog on Department of Homeland Security training, publications, programs, and services for State, local, and tribal law enforcement agencies, and for other purposes.; was reported to the Full Committee with a favorable recommendation, without amendment, by voice vote.

H.R, 2453, To amend the Homeland Security Act of 2002 to establish the Intelligence Rotational Assignment Program in the Department of Homeland Security, and for other purposes.; was reported to the Full Committee with a favorable recommendation, without amendment, by voice vote.

H.R. 2470, To require an annual homeland threat assessment, and for other purposes.; was reported to the Full Committee with a favorable recommendation, without amendment, by voice vote.
