## SUBCOMMITTEE ACTION

The Committee on Homeland Security's Subcommittee on Cybersecurity, Infrastructure Protection, and Security Technologies met, pursuant to notice, in open markup session, a quorum being present, on Wednesday, September 18, 2013, in 311 Cannon House Office Building to consider the following measures: H.R. 2952 (Mr. Meehan), To amend the Homeland Security Act of 2002 to make certain improvements in the laws relating to the advancement of security technologies for critical infrastructure protection, and for other purposes.; and H.R. 3107, (Ms. Clarke) to require the Secretary of Homeland Security to establish cybersecurity occupation classifications, assess the cybersecurity workforce, develop a strategy to address identified gaps in the cybersecurity workforce, and for other purposes.

The Subcommittee took the following actions:

H.R. 2952, To amend the Homeland Security Act of 2002 to make certain improvements in the laws relating to the advancement of security technologies for critical infrastructure protection, and for other purposes.; was reported to the Full Committee with a favorable recommendation, as amended, by voice vote.

The Subcommittee agreed to H.R. 2952, as amended, by voice vote.

The following amendments were offered:

An amendment to H.R. 2952 offered by Mr. Meehan (#1); Page 3, line 9, strike "the" and insert "any".

Page 5, beginning at line 16, strike "study on the use by the Department" and insert "report on the Department's utilization".

Page 5, line 20, strike "study" and insert "report".

Page 5 line 22, strike "study. The study" and insert "report. The Report".

Page 6, line 1, strike "Study.—The study" and insert "Report.—The report".

Page 7, beginning at line 18, strike "metrics to assist end-users in deploying timely and effective" and insert "performance and readiness metrics to assist end-users in deploying effective and timely"; was AGREED TO by voice vote.

An amendment to H.R. 2952 offered by Ms. Clarke (#2); Page 2, line 16, strike "(a) In General.—" and insert the following: (a) Strategic Plan; Public-private Consortiums.—

(1) In general.—

Page 4, after line 16, insert a new paragraph (5).

Page 6, after line 15, insert a new section (2) Limitation on progress report requirement.—; was AGREED TO by voice vote.

An amendment to H.R. 2952 offered by Mr. Keating (#3); Page 6, strike the closing quotation marks and the second period at line 15, and after line 15 insert a new section entitled "Sec. 320. Identification of Cybersecurity Risks to the Nuclear Reactors, Materials, and Waste Sector.";

Page 6, in the matter following line 18, in the item relating to section 319 strike the closing quotation marks and the section period, and after such item inser the following: "Sec. 320. Identification of Cybersecurity Risks to the Nuclear Reactors, Materials, and Waste Sector."; was WITHDRAWN by unanimous consent.

H.R. 3107, To require the Secretary of Homeland Security to establish cybersecurity occupation classifications, assess the cybersecurity workforce, develop a strategy to address identified gaps in the cybersecurity workforce, and for other purposes; was reported to the Full Committee with a favorable recommendation, as amended, by voice vote.

The Subcommittee agreed to H.R. 3107, as amended, by voice vote.

The following amendments were offered:

An en bloc amendment to H.R. 3107 offered by Mr. Meehan (#1) consisting of:

An amendment: In subparagraph (A) of section 2(c), strike "and" at the end.

In section 2(c), redesignate subparagraph (B) as subparagraph (C).

In section 2(c), insert after subparagraph (A) the following:

(B) a five-year implementation plans; and;

An amendment: In section 2, add at the end a new subsection entitled "(f) GAO Study."; was AGREED TO by voice vote.

Without objection, the Chair authorized staff to make technical and conforming corrections to H.R. 2952 and H.R. 3107.
