Ola is the current Chair of the national IT Sector Coordinating Council (IT SCC), which comprises the nation's top IT companies, professional services firms, and trade associations, and works in partnership with the Department of Homeland Security to address strategies for mitigating cybersecurity threats and risks to our nation's critical infrastructure. A champion and advocate for cybersecurity readiness for small- and medium-sized businesses, Ola frequently meets with and speaks to business groups and CEOs about cybersecurity. In March 2015, she testified to the Senate Committee on Commerce, Science, and Transportation, Subcommittee on Consumer Protection, Product Safety, Insurance, and Data Security about cybersecurity insurance and its impact on businesses, particularly small and medium-sized businesses.
