We received one grant in 2020 that was made available to our synagogue just as the COVID-19 pandemic was beginning. This was a NPSG through Homeland Security and FEMA, and it was implemented in Texas by the governor's office. The requirement was that the grant be used for the "hardening of the facility," so our fence, gate, parking lot lighting, and security cameras fit that requirement. We were also able to fund a security contract for times that we could not afford protection during the previous year.
