Dear Representative Capps:

On behalf of the Coalition for Pediatric Medical Research, representing leading children's hospitals responsible for treating our nation's sickest children today and conducting research to develop the therapies, treatments, and cures of tomorrow, we are writing to offer our deepest thanks for your sponsorship of **H.R. 225, the *National Pediatric Research Network Act***. This legislation is greatly needed to strengthen our nation's pediatric research enterprise, and we are grateful for your continued tireless efforts to advance and enact the bill this Congress.

As you know, challenges to our pediatric research system are many. These include the funding constraints faced by the biomedical research community more broadly as well as barriers that often prevent pediatric research institutions and initiatives from access to critical programs and services intended to bolster research capacity, acquire or offset the costs of advanced research resources and infrastructure, and to support the next generation of researchers striving to make pediatrics their focus. A growing body of evidence overwhelmingly demonstrates that therapies and interventions delivered early in life – during infancy, childhood and adolescence – prevents diseases and their life-long adverse impacts on health and economic contributions to society. Similarly, research on pediatric populations is useful for understanding the origin of adult-onset diseases and is useful in preventing and treating such conditions. When pediatric research as a whole struggles, so too do our nation's children because of the reduced focus and funding to pediatric-based disorders and because of limited access to innovations in care and treatments that help improve life and reduce healthcare costs.

The *National Pediatric Research Network Act* will authorize the establishment of a well-proven and evidence-based networked approach for addressing pediatric research. It will enable the National Institutes of Health to support multi-institution consortia conducting high-impact research into the most challenging pediatric issues of our day, and will strengthen our collective focus on pediatric rare diseases. We believe this approach is particularly cost-effective because research networks foster high levels of collaboration, coordination, and resource sharing.

Every single day, our institutions care for tens of thousands of children, a number of whom are suffering from the most deadly and complex diseases. We strive each and every day to provide optimal levels of care informed by the latest scientific and medical knowledge. Thanks to research breakthroughs achieved over the years, we have made progress in treating a number of conditions that not too long ago were considered near-certain death sentences. But making continued progress to heal children today and tomorrow will require a renewed commitment to our nation's children.

We thank you for recognizing the urgent need that exists to enact the *National Pediatric Research Network Act*, and gratefully appreciate your efforts to enable early action on this bill in the 113th Congress. We particularly want to acknowledge Adriane Casalotti of your staff for her hard work on behalf of this important cause, especially over the past year.
