To amend the Energy Policy and Conservation Act to permit exemptions for external power supplies from certain efficiency standards, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "EPS Service Parts
- 5 Act of 2014".

1 SEC. 2. EXEMPT SUPPLIES.

2	Section 325(u) of the Energy Policy and Conserva-
3	tion Act (42 U.S.C. 6295(u)) is amended by adding at
4	the end the following:
5	"(5) Exempt supplies.—
6	"(A) February 10, 2014, Rule.—
7	"(i) In general.—An external power
8	supply shall not be subject to the final rule
9	entitled 'Energy Conservation Program:
10	Energy Conservation Standards for Exter-
11	nal Power Supplies', published at 79 Fed.
12	Reg. 7845 (February 10, 2014), if the ex-
13	ternal power supply—
14	"(I) is manufactured during the
15	period beginning on February 10,
16	2016, and ending on February 10,
17	2020;
18	"(II) is marked in accordance
19	with the External Power Supply
20	International Efficiency Marking Pro-
21	tocol, as in effect on February 10,
22	2016;
23	"(III) meets, where applicable,
24	the standards under paragraph
25	(3)(A), and has been certified to the
26	Secretary as meeting International

1	Efficiency Level IV or higher of the
2	External Power Supply International
3	Efficiency Marking Protocol, as in ef-
4	fect on February 10, 2016; and
5	"(IV) is made available by the
6	manufacturer as a service part or a
7	spare part for an end-use product
8	that—
9	"(aa) constitutes the pri-
10	mary load; and
11	"(bb) was manufactured be-
12	fore February 10, 2016.
13	"(ii) Reporting.—The Secretary
14	may require manufacturers of products ex-
15	empted pursuant to clause (i) to report an-
16	nual total units shipped as service and
17	spare parts that are not International Effi-
18	ciency Level VI or higher.
19	"(iii) Limitation of exemption.—
20	The Secretary may issue a rule, after pro-
21	viding public notice and opportunity for
22	public comment, to limit the applicability
23	of the exemption established under clause
24	(i) if the Secretary determines that the ex-
25	emption is resulting in a significant reduc-

1	tion of the energy savings that would oth-
2	erwise result from the final rule described
3	in such clause.
4	"(B) Amended standards.—
5	"(i) In General.—The Secretary
6	may exempt an external power supply from
7	any amended standard under this sub-
8	section if the external power supply—
9	"(I) is manufactured within four
10	years of the compliance date of the
11	amended standard;
12	"(II) complies with applicable
13	marking requirements adopted by the
14	Secretary prior to the amendment;
15	"(III) meets the standards that
16	were in effect prior to the amendment;
17	and
18	"(IV) is made available by the
19	manufacturer as a service part or a
20	spare part for an end-use product
21	that—
22	"(aa) constitutes the pri-
23	mary load; and

1	"(bb) was manufactured be-
2	fore the compliance date of the
3	amended standard.
4	"(ii) Reporting.—The Secretary
5	may require manufacturers of a product
6	exempted pursuant to clause (i) to report
7	annual total units shipped as service and
8	spare parts that do not meet the amended
9	standard.".
