## AMENDMENT TO THE COMMITTEE PRINT FOR H.R. 212

## OFFERED BY MRS. CAPPS OF CALIFORNIA

After section 2, add the following new section:

1	SEC. 3. AMENDMENT TO THE SAFE DRINKING WATER ACT
2	RELATING TO RISKS OF CLIMATE CHANGE TO
3	DRINKING WATER.
4	Part E of the Safe Drinking Water Act (42 U.S.C.
5	300j et seq.) (as amended by section 2 of this Act) is
6	amended by adding at the end the following new section:
7	"SEC. 1460. CLIMATE CHANGE RISK ASSESSMENT AND MAN-
8	AGEMENT.
9	"(a) Strategic Plan.—
10	"(1) Development.—Not later than 90 days
11	after the date of enactment of this section, the Ad-
12	ministrator shall develop and submit to Congress a
13	strategic plan for assessing and managing the risks
14	of climate change to drinking water provided by pub-
15	lic water systems. The strategic plan shall include
16	steps and timelines to—
17	"(A) evaluate the risks posed by climate
18	change to drinking water provided by public
19	water systems;

1	"(B) establish a comprehensive list of the
2	effects of climate change on drinking water pro-
3	vided by public water systems which the Admin-
4	istrator determines may have an adverse effect
5	on human health;
6	"(C) summarize—
7	"(i) the known adverse human health
8	effects resulting from the effects of climate
9	change on drinking water included on the
10	list established under subparagraph (B);
11	"(ii) factors that cause climate
12	change; and
13	"(iii) factors that exacerbate the ef-
14	fects of climate change on drinking water
15	provided by public water systems;
16	"(D) with respect to the effects of climate
17	change on drinking water included on the list
18	established under subparagraph (B), determine
19	whether to—
20	"(i) establish guidance regarding fea-
21	sible analytical methods to quantify such
22	effects; and
23	"(ii) establish guidance regarding the
24	frequency of monitoring necessary to de-
25	tect such effects;

1	"(E) recommend feasible treatment op-
2	tions, including procedures, equipment, and
3	source water protection practices, to mitigate
4	any adverse public health effects resulting from
5	the effects of climate change on drinking water
6	included on the list established under subpara-
7	graph (B); and
8	"(F) enter into cooperative agreements
9	with, and provide technical assistance to, af-
10	fected States and public water systems, as iden-
11	tified by the Administrator, for the purpose of
12	managing risks associated with the effects of
13	climate change on drinking water included on
14	the list established under subparagraph (B).
15	"(2) UPDATES.—The Administrator shall, as
16	appropriate, update and submit to Congress the
17	strategic plan developed under paragraph (1).
18	"(b) Information Coordination.—In carrying out
19	this section the Administrator shall—
20	"(1) identify gaps in the Agency's under-
21	standing of the effects of climate change on drinking
22	water provided by public water systems, including—
23	"(A) the human health effects of climate
24	change; and

1	"(B) methods and means of testing and
2	monitoring for the effects of climate change in
3	source water of, or drinking water provided by,
4	public water systems;
5	"(2) as appropriate, consult with—
6	"(A) other Federal agencies that—
7	"(i) examine or analyze climate
8	change; or
9	"(ii) address public health concerns
10	related to climate change;
11	"(B) States;
12	"(C) operators of public water systems;
13	"(D) multinational agencies;
14	"(E) foreign governments;
15	"(F) research and academic institutions;
16	and
17	"(G) companies that provide relevant
18	drinking water treatment options; and
19	"(3) assemble and publish information from
20	each Federal agency that has—
21	"(A) examined or analyzed climate change;
22	or
23	"(B) addressed public health concerns re-
24	lated to climate change.

- 1 "(c) Use of Science.—The Administrator shall
- 2 carry out this section in accordance with the requirements
- 3 described in section 1412(b)(3)(A), as applicable.
- 4 "(d) Feasible.—For purposes of this section, the
- 5 term 'feasible' has the meaning given such term in section
- 6 1412(b)(4)(D).".
