A BILL

- To require the Secretary of Health and Human Services to develop a voluntary registry to collect data on cancer incidence among firefighters.
 - 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,

3 SECTION 1. SHORT TITLE.

4 This Act may be cited as the "Firefighter Cancer5 Registry Act of 2017".

6 SEC. 2. POPULATION-BASED REGISTRY FOR FIREFIGHTER 7 CANCER INCIDENCE.

8 (a) IN GENERAL.—The Secretary of Health and 9 Human Services, acting through the Director of the Centers for Disease Control and Prevention, shall develop and 10 11 maintain, directly or through a grant or cooperative agreement, a voluntary registry of firefighters (referred to in 12 this section as the "Firefighter Registry") to collect rel-13 evant history and occupational information of such fire-14 fighters that can be linked to available cancer registry 15 data collected by existing State cancer registries. 16

17 (b) USE OF FIREFIGHTER REGISTRY.—The Fire18 fighter Registry shall be used for the following purposes:
19 (1) To establish and improve collection infra20 structure and activities related to the nationwide

1	monitoring of the incidence of cancer among fire-
2	fighters.
3	(2) To collect, consolidate, store, and make
4	publicly available epidemiological information related
5	to cancer incidence and trends among firefighters.
6	(c) Relevant Data.—
7	(1) IN GENERAL.—In carrying out the vol-
8	untary data collection for purposes of inclusion
9	under the Firefighter Registry, the Secretary should
10	seek to include the following information:
11	(A) Identifiable information from a rep-
12	resentative sample size, as determined by the
13	Secretary under subsection $(d)(2)(A)$, of volun-
14	teer, paid-on-call, and career firefighters, inde-
15	pendent of cancer status or diagnosis.
16	(B) With respect to individual risk factors
17	and work history of firefighters, available infor-
18	mation on—
19	(i) basic demographic information, in-
20	cluding the age of the firefighter involved;
21	(ii) a listing of status of the fire-
22	fighter as either volunteer, paid-on-call, or
23	career firefighter;
24	(iii) the number of years on the job
25	and a detailing of additional employment

1	experience that was either performed con-
2	currently alongside firefighting service, be-
3	fore, or anytime thereafter;
4	(iv)(I) a measure of the number of
5	fire incidents attended as well as the type
6	of fire incidents (such as residential house
7	fire or commercial fire); or
8	(II) in the case of a firefighter for
9	whom information on such number and
10	type is not available, an estimate of such
11	number and type based on the method de-
12	veloped under subsection $(d)(2)$;
13	(v) a list of additional risk factors, in-
14	cluding smoking or drug use, as deter-
15	mined relevant by the Secretary; and
16	(vi) other physical examination and
17	medical history information relevant to a
18	cancer incidence study or general health of
19	firefighters not available in existing cancer
20	registries.
21	(C) Any additional information that is
22	deemed necessary by the Secretary.
23	(2) Diagnoses and treatment.—In carrying
24	out the data collection for purposes of inclusion
25	under the Firefighter Registry, with respect to diag-

1	noses and treatment of firefighters diagnosed with
2	cancer, the Secretary shall enable the Firefighter
3	Registry to link to State-based cancer registries, for
4	a purpose described by clause (vi) or (vii) of section
5	399B(c)(2)(D) of the Public Health Service Act (42)
6	U.S.C. 280e(c)(2)(D)), to obtain information on—
7	(A) administrative information, including
8	date of diagnoses and source of information;
9	and
10	(B) pathological data characterizing the
11	cancer, including cancer site, state of disease
12	(pursuant to Staging Guide), incidence, and
13	type of treatment.
14	(d) Methods.—
15	(1) IN GENERAL.—For the purposes described
16	in subsection (b), the Secretary is authorized to in-
17	corporate questions into public health surveys, ques-
18	tionnaires, and other databases.
19	(2) REQUIRED STRATEGY.—The Secretary shall
20	develop a strategy, working in consultation with the
21	stakeholders identified in subsection (e), to maximize
22	participation in the Firefighter Registry established
23	under this Act. At minimum, the strategy shall in-
24	clude the following:

(A) Identified minimum participation tar-

2 gets for volunteer, paid-on-call, and career fire-3 fighters. 4 (B) A strategy for increasing awareness of 5 the Firefighter Registry and maximizing par-6 ticipation among volunteer, paid-on-call, and ca-7 reer firefighters to meet minimum participation 8 targets. 9 (C) Additional steps that may be required 10 to ensure the equitable representation of groups 11 identified in paragraph (5). 12 (D) Information on how the Secretary will 13 store data described in subsection (c)(1) and 14 provide links to relevant health information de-15 scribed in subsection (c)(2). 16 (E) Working in consultation with the ex-17 perts described in subsection (e), a reliable and 18 standardized method for estimating the number 19 of fire incidents attended by a firefighter as 20 well as the type of fire incident so attended in 21 the case such firefighter is unable to provide 22 such information. 23 **REPORT TO CONGRESS.**—The Secretary (3)24 shall submit the strategy described in paragraph (2)

25 to the Committee on Energy and Commerce of the

House of Representatives and the Committee on
 Health, Education, Labor, and Pensions of the Sen ate not later than 30 days after the date of the com pletion of the strategy.

5 (4) GUIDANCE FOR INCLUSION AND MAINTE-6 NANCE OF DATA ON FIREFIGHTERS.—The Secretary 7 shall develop, in consultation with the stakeholders 8 identified in subsection (e), State health agencies, 9 State departments of homeland security, and volun-10 teer, paid-on-call, combination, and career fire-11 fighting agencies, a strategy for inclusion of fire-12 fighters in the registry that are representative of the 13 general population of firefighters, that outlines the 14 following:

15 (A) How new information about fire16 fighters will be submitted to the Firefighter
17 Registry for inclusion.

18 (B) How information about firefighters will
19 be maintained and updated in the Firefighter
20 Registry over time.

(C) A method for estimating the number of
fire incidents attended by a firefighter as well
as the type of fire incident so attended in the
case such firefighter is unable to provide such
information.

(D) Further information, as deemed nec essary by the Secretary.

3 (5) ENSURING REPRESENTATION OF UNDER4 REPRESENTED GROUPS IN REGISTRY.—In carrying
5 out this section, the Secretary shall take such meas6 ures as the Secretary deems appropriate to encour7 age the inclusion of data on minority, female, and
8 volunteer firefighters in the Firefighter Registry es9 tablished under this section.

(e) CONSULTATION.—The Secretary shall, on a regular basis, seek feedback regarding the utility of the Firefighter Registry established under this section and ways
the Firefighter Registry can be improved from non-Federal experts in the following areas:

(1) Public health experts with experience in de-veloping and maintaining cancer registries.

17 (2) Epidemiologists with experience in studying18 cancer incidence.

19 (3) Clinicians with experience in diagnosing and20 treating cancer incidence.

(4) Active and retired volunteer, paid-on-call,
and career firefighters as well as relevant national
fire and emergency response organizations.

24 (f) RESEARCH AVAILABILITY.—The Secretary shall25 develop and make public a process for de-identifying data

from the Firefighter Registry and making such data avail-1 2 able without a fee for research or other purposes. Such 3 process shall provide that such data shall be made avail-4 able for such research purposes only if there is an agree-5 ment to make findings, journal articles, or other print or 6 web-based publications derived from such research public 7 or available to the relevant stakeholders identified in sub-8 section (e).

9 (g) PRIVACY.—In carrying out this Act, the Secretary 10 shall apply to the Firefighter Registry developed under 11 subsection (a) data security provisions and privacy stand-12 ards that comply with the best practices of the Centers for Disease Control and Prevention and provide for data 13 privacy and security standards similar to those in the 14 15 HIPAA privacy regulation, as defined insection 16 1180(b)(3) of the Social Security Act (42 U.S.C. 1320d-17 9(b)(3)).

(h) AUTHORIZATION OF FUNDS.—To carry out this
section, there are authorized to be appropriated
\$2,500,000 for each of the fiscal years 2018 through
2022.
