2	followed in allocating grant funds awarded
3	under this section among grantees; and
4	"(B) submit the formula methodology to—
5	"(i) the Committee on Energy and
6	Commerce and the Committee on Appro-
7	priations of the House of Representatives;
8	and
9	"(ii) the Committee on Health, Edu-
10	cation, Labor and Pensions and the Com-
11	mittee on Appropriations of the Senate.
12	"(4) Use of funds.—Grants awarded under
13	this subsection shall be used for carrying out activi-
14	ties that supplement activities pertaining to sub-
15	stance use disorders of significance, including opioid
16	and stimulant use disorders, undertaken by the
17	State agency responsible for administering the sub-
18	stance abuse prevention and treatment block grant

7	pain management, recognizing potential cases
8	of substance abuse, referral of patients to treat-
9	ment programs, preventing diversion of con-
10	trolled substances, and overdose prevention.
11	"(D) Supporting access to health care
12	services, including—
13	"(i) services provided by federally cer-
14	tified opioid treatment programs;
15	"(ii) outpatient and residential sub-
16	stance use disorder treatment services that
17	utilize medication-assisted treatment, as
18	appropriate; or
19	"(iii) other appropriate health care
20	providers to treat substance use disorders.
21	"(E) Other public health-related activities,
22	as the State, Indian Tribe, or Tribal organiza-
23	tion determines appropriate, related to address-
24	ing substance use disorders within the State,
25	Indian Tribe, or Tribal organization, including

1	directing resources in accordance with local
2	needs related to substance use disorders.
3	"(c) Accountability and Oversight.—A State re-
4	ceiving a grant under subsection (b) shall include in re-
5	porting related to substance abuse submitted to the Sec-
6	retary pursuant to section 1942 of the Public Health Serv-
7	ice Act (42 U.S.C. 300x-52), a description of—
8	"(1) the purposes for which the grant funds re-
9	ceived by the State under such subsection for the
10	preceding fiscal year were expended and a descrip-
11	tion of the activities of the State under the grant;
12	and
13	"(2) the ultimate recipients of amounts pro-
14	vided to the State through the grant.
15	"(d) Limitations.—Any funds made available pur-
16	suant to subsection (i)—
17	"(1) notwithstanding any transfer authority in
18	any appropriations Act, shall not be used for any
19	purpose other than the grant program in subsection
20	(b); and
21	"(2) shall be subject to the same requirements
22	as substance abuse prevention and treatment pro-
23	grams under titles V and XIX of the Public Health
24	Service Act (42 U.S.C. 290aa et seq., 300w et seq.).

- 1 "(e) Indian Tribes and Tribal Organizations.—
- 2 The Secretary, in consultation with Indian Tribes and

- 7 "(f) Report to Congress.—Not later than Sep-

7	cation Assistance Act (25 U.S.C. 5304).
8	"(2) Tribal organization.—The term 'Tribal
9	organization' has the meaning given the term 'tribal
10	organization' in such section 4.
11	"(3) State.—The term 'State' has the mean-
12	ing given such term in section 1954(b) of the Public
13	Health Service Act (42 U.S.C. 300x-64(b)).
14	"(i) Authorization of Appropriations.—
15	"(1) In general.—For purposes of carrying
16	out the grant program under subsection (b), there is
17	authorized to be appropriated \$1,500,000,000 for
18	each of fiscal years 2020 through 2026, to remain
19	available until expended.
20	"(2) Federal administrative expenses.—
21	Of the amounts made available for each fiscal year
22	to award grants under subsection (b), the Secretary
23	shall not use more than 2 percent for Federal ad-
24	ministrative expenses, training, technical assistance,
25	and evaluation.

1	"(3) Set aside.—Of the amounts made avail-
2	able for each fiscal year to award grants under sub-
3	section (b) for a fiscal year, the Secretary shall—
4	"(A) award 5 percent to Indian Tribes and
5	Tribal organizations; and
6	"(B) of the remaining amount, set aside
7	up to 15 percent for States with the highest
8	age-adjusted rate of drug overdose death based
9	on the ordinal ranking of States according to
10	the Director of the Centers for Disease Control
11	and Prevention.".

Amend the title so as to read: "A bill to amend the 21st Century Cures Act to reauthorize and expand a grant program for State response to the opioid abuse crisis, and for other purposes.".
