## BILL: H.R. 1754, the "Horseracing Integrity Act of 2019"

AMENDMENT: An Amendment to the Nature of a Substitute (AINS), No. 1, offered by Mr. Tonko of New York, to establish minimum standards for racing surfaces, pre-race inspections, equine medical directors, workout requirements, and safety stewards. Provides federal recognition and enforcement power to the Horseracing Integrity and Safety Authority (the "Authority"), an independent, non-governmental regulatory body, to develop and implement a horseracing anti-doping and medication control program and a racetrack safety program.

## **DISPOSITION:** AGREED TO by a roll call vote of 46 yeas to 5 nays.
