- 3 (a) In General.—Title V of the Communications
- 4 Act of 1934 (47 U.S.C. 501 et seq.) is amended by adding
- 5 after section 501, the following new section:
- 6 "§ 501A. Enhanced general penalty
- 7 "(a) Offenses.—Whoever, during and in relation to
- 8 a violation enumerated in section 501, willfully or mali-
- 9 ciously destroys any communications facility, in addition
- 10 to the punishment provided for a violation that includes
- 11 imprisonment, be sentenced to a term of imprisonment of
- 12 2 years.
- 13 "(b) Consecutive Sentence.—Notwithstanding
- 14 any other provision of law—
- 15 "(1) a court may not place on probation any
- person convicted of a violation of this section;
- 17 "(2) except as provided in paragraph (3), a
- term of imprisonment imposed on a person under

1	this section may not run concurrently with any other
2	term of imprisonment imposed on the person under
3	any other provision of law, including any term of im-
4	prisonment imposed for the violation of this section;
5	and
6	"(3) a term of imprisonment imposed on a per-
7	son for a violation of this section may, in the discre-
8	tion of the court, run concurrently, in whole or in
9	part, only with another term of imprisonment that
10	is imposed by the court at the same time on that
11	person for an additional violation of this section, if
12	the discretion is exercised in accordance with appli-
13	cable guidelines and policy statements issued by the
14	Sentencing Commission pursuant to section 994 of
15	title 28, United States Code.
16	"(c) Communications Facility Defined.—In this
17	section, the term 'communications facility' includes—
18	"(1) any infrastructure, including any transmit-
19	ting device, tower, or support structure, and any
20	equipment, switches, wiring, cabling, power sources,
21	shelters, or cabinets, associated with the licensed or
22	permitted unlicensed wireless or wireline trans-
23	mission of writings, signs, signals, data, images, pic-
24	tures, and sounds of all kinds; and
25	"(2) any antenna or apparatus that—

1	"(A) is designed for the purpose of emit-
2	ting radio frequency;
3	"(B) is designed to be operated, or is oper-
4	ating, from a fixed location pursuant to author-
5	ization by the Commission or is using duly au-
6	thorized devices that do not require individual
7	licenses; and
8	"(C) is added to a tower, building, or other
9	structure.".
