At the end of subtitle D, add the following new chapter:

CHAPTER 4—OTHER MATTER 1 SEC. 3331. SALES OF CABLE SYSTEMS. 3 (a) In General.—Section 627 of the Communica-4 tions Act of 1934 (47 U.S.C. 547) is amended to read: 5 "SEC. 627. CONDITIONS OF SALE OR TRANSFER. 6 "(b) Value of Cable System Upon Sale or 7 Transfer.— 8 "(1) AFTER DENIAL OF FRANCHISE 9 NEWAL.—If a renewal of a franchise held by a cable 10 operator is denied and the franchising authority ac-11 quires ownership of the cable system or effects a 12 transfer of ownership of the system to another per-13 son, any such acquisition or transfer shall be at fair 14 market value, determined on the basis of the cable 15 system valued as a going concern but with no value 16 allocated to the franchise itself.

"(2) After revocation of franchise for

1	revoked for cause and the franchising authority ac-
2	quires ownership of the cable system or effects a
3	transfer of ownership of the system to another per-
4	son, any such acquisition or transfer shall be at fair
5	market value.
6	"(c) Limitations on Authority of Franchising
7	AUTHORITY WITH RESPECT TO TRANSFER OF FRAN-
8	CHISE.—
9	"(1) In General.—A franchising authority
10	may not—
11	"(A) preclude a cable operator from trans-
12	ferring a franchise to a person to which such
13	franchise was not initially granted; or
14	"(B) require a cable operator to which a
15	franchise is initially granted to receive approval
16	from the franchising authority for the transfer
17	of such franchise to a person who to which such
18	franchise was not initially granted.
19	"(2) Notification.—In the case of the trans-
20	fer of a franchise to a person to which such fran-
21	chise was not originally granted, a franchising au-
22	thority may require a cable operator to which a fran-
23	chise was initially granted to, not later than 15 days
24	after a transfer of a franchise, notify the franchising
25	authority in writing of such transfer.

1	"(3) Transfer Defined.—In this subsection,
2	the term 'transfer' means the assignment rights
3	under a franchise through any transaction, including
4	a merger, sale, assignment, restructuring, or trans-
5	fer of control of a cable operator or a cable sys-
6	tem.".
7	(b) Effective Date.—This section, and the amend-
8	ments made by subsection (a), shall take effect 6 months
9	after the date of the enactment of this Act.
10	(c) APPLICATION.—This section, and the amendment
11	made by subsection (a), shall apply to a franchise grant-
12	ed—
13	(1) on or after the effective date established by
14	subsection (b); or
15	(2) before such date, if such franchise (includ-
16	ing any renewal term thereof) is in effect on such
17	date.
