Dear Chairman Pallone:

Public Health Jobs Now! and the undersigned organizations, representing leading public health experts, labor unions, grassroots advocates, anti-poverty organizations, racial justice organizations, community health groups, community-based organizations, community organizers, faith leaders, women and moms, and academic researchers, applauds the U.S. House Energy and Commerce Committee for inclusion of programs to build a public health workforce in the Energy & Commerce Committee's COVID-19 Relief Budget Reconciliation Legislation, intended for the budget reconciliation process. Major investments in a coordinated public health workforce program are crucial to standing up an effective pandemic response, gaining public trust, vaccinating and controlling epidemiological spread, and healing and rebuilding our communities. These investments will be particularly helpful in Black and brown communities that have been so hard hit.

The U.S. public health system had been underfunded and hollowed out by a decade of cuts. Since 2010, spending on state public health departments dropped 16% and spending on local health departments was down 18%.¹ Over 50,000 public health jobs have been lost since the Great Recession while the overall population has grown, leaving the country woefully underprepared and short-staffed.² With the recent availability of vaccines, the current size of the public health workforce has become even more inadequate as personnel are reallocated to vaccination campaigns, shuttering essential testing and contact tracing operations across the country.³,4,5 Furthermore, epidemic control activities for COVID-19 have drawn personnel away from other worsening health crises, such as mental illness, addiction, and other infectious diseases.

Therefore, we are encouraged that the public health workforce in the Energy & Commerce Committee's COVID-19 Relief Budget Reconciliation Legislation is modeled after aspects of

H.R. 460 Health Force, Resilience Force, and Jobs to Fight COVID-19 Act. In particular we need to ensure that state and local health departments, via funding and guidance from the CDC, have the resources to create—in partnership with labor and community-based organizations—a coordinated, aligned and efficient public health response to crush this virus and build back a better and more inclusive public health system. Beyond COVID-19, we can set the entire country—rural and urban areas alike—on the path to healthier, stronger communities by providing much needed investment in our public health infrastructure and creating good permanent union jobs that will create opportunities for the communities most impacted by COVID-19. Black and Latina women and women with disabilities have experienced disparate rates of pandemic-related job loss and continue to face persistent unemployment.⁶ Thus, the creation of permanent jobs is vital to addressing structural inequity faced by historically marginalized groups.

We look forward to working with the Committee to ensure that a permanent cadre of public health jobs can be modeled after *H.R.* 460 Health Force so the nation can address long-standing racial inequities by making sure community groups, unions, and other local stakeholders have a voice in shaping public health priorities at the local level.

Americans across the political spectrum recognize the urgent need for a major new public health jobs corps to fight COVID-19, with 75% of likely voters, including 61% of Republicans, supporting the creation of such a program.⁷ Our public health system simply lacks the workforce to address the COVID-19 crisis and without a public health workforce program along the lines of *H.R. 460*, we will not be able to mobilize a response capable of protecting, healing and rebuilding our communities.
