7 SEC. 11. SHORT TITLE.

8 This division may be cited as the "Federal Trade

11 SEC. 12. TRANSFER.

Notwithstanding any other provision of law and not
later than December 31, 2022, the Administrator of General Services shall transfer administrative jurisdiction,
custody, and control of the building located at 600 Penn-

sylvania Avenue, NW., District of Columbia, to the Na tional Gallery of Art for the purpose of housing and exhib iting works of art and to carry out administrative func tions and other activities related to the mission of the Na tional Gallery of Art.

6 SEC. 13. REMODELING, RENOVATING, OR RECON7 STRUCTING.

8 (a) IN GENERAL.—The National Gallery of Art shall
9 pay for the costs of remodeling, renovating, or recon10 structing the building referred to in section 12.

(b) FEDERAL SHARE.—No appropriated funds may
be used for the initial costs for the remodeling, renovating,
or reconstructing of the building referred to in section 12.

(c) PROHIBITION.—The National Gallery of Art may
not use sale, lease, or exchange, including leaseback arrangements, for the purposes of remodeling, renovating,
or reconstructing the building referred to in section 12. **SEC. 14. RELOCATION OF THE FEDERAL TRADE COMMIS-**SION.

(a) RELOCATION.—Not later than the date specified
in section 12, the Administrator of General Services shall
relocate the Federal Trade Commission housed in the
building identified in section 12 to such other building in
the District of Columbia owned by the Government that

the Administrator of General Services considers appro priate.

3 (b) RENT.—The rental rate applied to the Federal 4 Trade Commission by the Administrator of the General 5 Services for use of the building identified in section 12 6 as of the date of enactment of this Act shall apply to re-7 placement space provided by the Administrator pursuant 8 to subsection (a) for 10 years after the relocation of such 9 Commission.

10 SEC. 15. NATIONAL GALLERY OF ART.

Beginning on the date that the National Gallery ofArt occupies the building referred to in section 12—

(1) the building shall be known and designated
as the "North Building of the National Gallery of
Art"; and

16 (2) any reference in a law, map, regulation,
17 document, paper, or other record of the United

21 SEC. 16. SAVINGS.

All savings under this division shall be placed in a restitution fund for victims of unfair or deceptive acts or practices related to the COVID-19 pandemic, including

- 2 tion, or diagnosis of COVID–19.
