## A BILL

To extend the Gabriella Miller Kids First Pediatric Research Program at the National Institutes of Health, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-

- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Gabriella Miller Kids
- 5 First Research Act 2.0".

1	SEC. 2. FUNDING FOR THE PEDIATRIC RESEARCH INITIA-
2	TIVE.
3	The Public Health Service Act (42 U.S.C. 201 et
4	seq.) is amended—
5	(1) in section $402A(a)(2)$ (42 U.S.C.
6	282a(a)(2))—
7	(A) in the heading—
8	(i) by striking "10-YEAR"; and
9	(ii) by striking "THROUGH COMMON
10	FUND";
11	(B) by striking "to the Common Fund"
12	and inserting "to the Division of Program Co-
13	ordination, Planning, and Strategic Initiatives";
14	(C) by striking "10-Year";
15	(D) by striking "and reserved under sub-
16	section (c)(1)(B)(i) of this section"; and
17	(E) by striking "2014 through 2023" and
18	inserting "2024 through 2028";
19	(2) in each of paragraphs (1)(A) and (2)(C) of
20	section $402A(c)$ (42 U.S.C. $282a(c)$ ), by striking

1	SEC. 3. COORDINATION OF NIH FUNDING FOR PEDIATRIC
2	RESEARCH.
3	(a) Sense of Congress.—It is the sense of the Con-
4	gress that the Director of the National Institutes of
5	Health should continue to oversee and coordinate research
6	that is conducted or supported by the National Institutes
7	of Health for research on pediatric cancer and other pedi-
8	atric diseases and conditions, including through the Pedi-
9	atric Research Initiative Fund.
10	(b) Avoiding Duplication.—Section
11	402(b)(7)(B)(ii) of the Public Health Service Act (42
12	U.S.C. 282(b)(7)(B)(ii)) is amended by inserting "and
13	shall prioritize, as appropriate, such pediatric research
14	that does not duplicate existing research activities of the
15	National Institutes of Health" before "; and".
16	SEC. 4. REPORT ON PROGRESS AND INVESTMENTS IN PEDI-
17	ATRIC RESEARCH.
18	Not later than 5 years after the date of the enact-
19	ment of this Act, the Secretary of Health and Human
20	Services shall submit to the Committee on Energy and
21	Commerce of the House of Representatives and the Com-
22	mittee on Health, Education, Labor, and Pensions of the
23	Senate a report that—
24	(1) details pediatric research projects and ini-
25	tiatives receiving funds allocated pursuant to section

1	402(b)(7)(B)(ii) of the Public Health Service Act
2	(42 U.S.C. 282(b)(7)(B)(ii)); and
3	(2) summarizes advancements made in pediatric
4	research with funds allocated pursuant to such sec-
5	tion.
