BILL: H.R. 7655, Pipeline Safety, Modernization, and Expansion Act of 2024

AMENDMENT: An amendment offered by Rep. Castor, **No. 4**, prohibits any members of the technical safety standards committees from having consulted for, worked for, or researched for a pipeline, petroleum, or gas company 3 years prior to selection or while serving on the committee.

DISPOSITION: NOT AGREED TO, by a roll call vote of 15 yeas to 26 nays.
