AMENDMENT TO H.R. 2483

OFFERED BY MR. JAMES OF MICHIGAN

At the end of the bill, add the following:

1 **SEC. ____.** **SUBSTANCE ABUSE TREATMENT SERVICES FOR**
2 **CHILDREN, ADOLESCENTS, AND YOUNG**
3 **ADULTS.**

4 Section 7102(c) of the SUPPORT for Patients and
5 Communities Act (42 U.S.C. 290bb–7a(c)), as amended
6 by sections 110(a) and 304, is further amended—

7 (1) in paragraph (1), by inserting “and suicide”
8 before “for children”;

9 (2) in paragraph (2)(A)—

10 (A) in clause (vi), by striking “or” at the
11 end;

12 (B) in clause (vii), by striking the period
13 at the end and inserting “; or”; and

14 (C) by adding at the end the following:

15 “(viii) a health care agency, health
16 care site, facility, nonprofit entity, or pro-
17 vider treating children and adolescents (in-
18 cluding any such agency, site, facility, or
19 provider specializing in pediatrics and fam-

1 ily medicine), a child and adolescent men-
2 tal and behavioral health specialist, a chil-
3 dren’s hospital, a hospital emergency de-
4 partment, or a health facility or program
5 operated by or in accordance with a con-
6 tract with or grant from the Indian Health
7 Service.”;

8 (3) in paragraph (4)—

9 (A) in subparagraph (B), by striking “or”
10 at the end;

11 (B) in subparagraph (C), by striking the
12 period at the end and inserting “; or”; and

13 (C) by adding at the end the following:

14 “(D) in the case of an eligible entity de-
15 scribed in paragraph (2)(A)(viii), or in the case
16 of an eligible entity that is an Indian tribe or
17 a tribal organization, interventions, with the
18 consent of parents or legal guardians of minors,
19 to support the prevention of, treatment of, and
20 recovery from suicide or overdose by children,
21 adolescents, and young adults, by—

22 “(i) providing counseling to parents or
23 legal guardians on best practices to pre-
24 vent overdose and suicide; and

1 “(ii) furnishing supplies to parents or
2 legal guardians to prevent the misuse of le-
3 thal means commonly used in overdose or
4 suicide.”; and

5 **[(4) in paragraph (9)—]**

6 **[(A) by striking “2019 through 2023” and**
7 **inserting “2024 through 2028”;]**

8 **[(B) by striking “There is authorized”**
9 **and inserting the following:]**

10 **[(“ (A) IN GENERAL.—There is author-**
11 **ized”; and]**

12 **[(C) by adding at the end the following:]**

13 **[(“ (B) ALLOCATION OF AMOUNTS.—Of the**
14 **amount appropriated under subparagraph (A)**
15 **for a fiscal year, not less than \$2,000,000 shall**
16 **be allocated to awarding grants pursuant to**
17 **subparagraphs (A), (B), and (C) of paragraph**
18 **(4).”.*****[NOTE: This amendment overlaps with***
19 ***the amendment in section 304(7) of H.R. 2483.***
