A BILL

To amend the Energy Conservation and Production Act to repeal certain Federal building energy efficiency performance standards, and for other purposes.

1 SECTION 1. SHORT TITLE.

- 2 This Act may be cited as the "Reliable Federal Infra-
- 3 structure Act".
- 4 SEC. 2. REVISED FEDERAL BUILDING ENERGY EFFICIENCY
- 5 PERFORMANCE STANDARDS.
- 6 (a) IN GENERAL.—Section 305(a)(3)(D)(i) of the
- 7 Energy Conservation and Production Act (42 U.S.C.
- 8 6834(a)(3)(D)(i)) is amended—
- 9 (1) by striking subclauses (I) and (II); and
- 10 (2) in subclause (III), by inserting after the
- third sentence the following: "The certification sys-
- tem and level may not prohibit a building from ob-
- taining a certification as a green building or high-
- performance green building solely based on direct or
- indirect consumption of fossil fuels.".
- 16 (b) Standards.—
- 17 (1) Repeal of Certain Standards.—Sub-
- part B of part 435, and subpart B of part 433, of
- title 10, Code of Federal Regulations, as in effect on
- the day before the date of enactment of this Act,

1 Conservation and Production Act (42)U.S.C. 2 6834(a)(3)(D)) to carry out the amendments made 3 by subsection (a)(1) of this section, such section 4 305(a)(3)(D) shall be implemented as though the re-5 quirements of subclauses (I) and (II) of clause (i) of 6 such section 305(a)(3)(D) (as in effect on the day 7 before the date of enactment of this Act) had never 8 taken effect. 9 (c) Conforming Amendment.—Section 436(h) of 10 the Energy Independence and Security Act of 2007 (42) U.S.C. 17092(h)) is amended by adding at the end the following: 12 13 "(3) Prohibition.—The system identified 14 under paragraph (1) may not prohibit a building 15 from obtaining a certification as a green building or high-performance green building solely based on di-16 17 rect or indirect consumption of fossil fuels.". 18 (d) REVISION OF REGULATIONS.—Not later than 180 19 days after the date of enactment of this Act, the Secretary 20 of Energy shall issue such new or revised regulations as 21 the Secretary determines necessary to carry out the 22 amendments made by this Act.
