A BILL

To prohibit the Secretary of Energy from enforcing energy efficiency standards applicable to manufactured housing, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Affordable Housing
- 5 Over Mandating Efficiency Standards Act" or the "Af-
- 6 fordable HOMES Act".

1	SEC. 2. RECOMMENDATIONS FOR REVISIONS TO STAND-
2	ARDS FOR MANUFACTURED HOUSING.
3	(a) Recommendations.—Section 413 of the Energy
4	Independence and Security Act of 2007 (42 U.S.C.
5	17071) is amended—
6	(1) by amending subsection (a) to read as fol-
7	lows:
8	"(a) Recommendations for Revisions to Stand-
9	ARDS.—The Secretary may transmit to the Secretary of
10	Housing and Urban Development recommendations for re-
11	visions to the preemptive energy conservation standards
12	established under section 604(g) of the Housing and Com-
13	munity Development Act of 1974 (42 U.S.C. 5403(g)).";
14	(2) by amending subsection (b) to read as fol-
15	lows:
16	"(b) Criteria for Recommendations.—Any rec-
17	ommendations for revisions to a preemptive energy con-
18	servation standard transmitted under this section shall—
19	"(1) be based on a determination of the cost-
20	effectiveness of such standard as proposed to be re-
21	vised, taking into consideration life cycle construc-
22	tion and operating costs; and
23	"(2) include estimates of the impact of such
24	standard as proposed to be revised on the initial
25	purchase price of manufactured homes; and
26	"(3) be developed taking into consideration—

1	"(A) factory construction techniques and
2	limitations unique to manufactured homes;
3	"(B) climate zones established by the Sec-
4	retary of Housing and Urban Development;
5	"(C) alternative methods that achieve
6	equivalent or improved energy performance as
7	compared to such standard as proposed to be
8	revised; and
9	"(D) estimated payback periods for any
10	added costs arising from such standard as pro-
11	posed to be revised."; and
12	(3) by striking subsection (e).
13	(b) No Force or Effect.—The final rule titled
14	"Energy Conservation Program: Energy Conservation
15	Standards for Manufactured Housing" published by the
16	Department of Energy in the Federal Register on May
17	31, 2022 (87 Fed. Reg. 32728), shall have no force or
18	effect.

Amend the title so as to read: "A bill to authorize the Secretary of Energy to transmit to the Secretary of Housing and Urban Development recommendations for changes to preemptive energy conservation standards applicable to manufactured homes.".
