FEHBP

WellPoint, along with the other 38 Blue Plans nationwide, administers the Blue Cross and Blue Shield Association's Service Benefit Plan in its service areas. The Service Benefit Plan is part of the Federal Employee Health Benefits Program (FEHBP) which provides coverage for its more than 8 million civilian employees, retirees (annuitants) and their dependents.

FEP HMO

WellPoint companies also have direct contracts with the U. S. Office of Personnel Management to offer HMO coverage for federal employees and annuitants in California, Missouri, and Virginia.
