Thomas P. Galati Chief of Intelligence New York City Police Department

Chief Thomas Galati is a thirty-two year veteran of the New York City Police Department. Initially appointed in 1984, he has held every rank from police officer through Chief. In 2013 he became the first person ever to hold the title of Chief of Intelligence of the NYPD. Immediately prior to that appointment he was the Commanding Officer of the Intelligence Division.

As Chief of Intelligence, Chief Galati is responsible for the activities the Intelligence Bureau, the western hemispheres largest municipal law enforcement intelligence operation. His wide-ranging responsibilities include criminal intelligence, intelligence collection, analysis and dissemination. He also functions as the lead for directing and coordinating investigative response between the NYPD and outside agencies such as the FBI, United States Secret Service, State Department, Department of Homeland Security and numerous international law enforcement partners.

Intelligence Bureau investigators and analysts develop operational intelligence and conduct investigations concerning threats of terrorism against, and complex criminal investigations inside, New York City. Among the significant terrorism cases Chief Galati has directed are the first successful state-level terrorism investigation in the United States that led to a conviction, the long-term investigation and disruption of a lone actor who assembled improvised explosive devices and planned to strike military housing facilities, and the first ever material support for terrorism case brought at a state level. In addition, he has worked with several FBI Joint Terrorism Task Forces for successful terrorism prosecutions.

The Public Security Section of the Intelligence Bureau develops security plans for large-scale events such as the annual United Nations General Assembly, and visits from heads of state, the US President, and Papal visits. Chief Galati is also responsible for overall security of the Mayor of New York City, City Hall and Gracie Mansion. In this mission he relies on analytic personnel, risk management, and threat assessments to develop, recommend and implement strategies for citywide threat protection.

During his tenure he has recruited and deployed the entire cadre of twelve international liaison posts for the New York City Police Department. These officers are assigned with law enforcement counterparts in Paris, Singapore, Amman, London, Madrid, Abu Dhabi, Tel Aviv, Santo Domingo, Sydney, Toronto and Montreal. The NYPD liaison to Interpol is posted in Lyon, France and a recently announced Europol post in the Hague will be deployed soon.

Prior to his assignment to Intelligence, Chief Galati held the titles of Commanding Officer in the Gang Division, 46th, and 47th Precincts in the Bronx. In each of these assignments, as well as in the Intelligence Division his command earned the prestigious NYPD Unit Citation awarded yearly to one-percent of NYPD commands for exceptional service.

Chief Galati holds a Bachelor of Science Degree in Criminal Justice from the State University of New York, is a 2003 graduate of the Police Management Institute of Columbia University, and is a 2011 graduate of the Harvard University, John F. Kennedy School of Government, Senior Executive Course.

Chief Galati was a 1989 recipient of the NYPD Medal of Valor. Numerous law enforcement organizations have recognized him for his contributions including the Columbia Association, the Desi Society, the Korean American Officers Association and the National Association of Carabinieri. The Anti-Defamation League recognized him in 2011 with their Gorowitz Institute Service Award. In 2014 he was awarded both the NECO-Ellis Island Medal of Honor and the Robert Colangelo Award by the American Academy for Professional Law Enforcement.
