SERVICE ACTIVITIES SUMMARY

My service activities are deeply rooted in my commitment to women's health and social justice. These activities are grounded in my mission to support the professional development of low-income and women of color. Ensuring a diverse workforce in the health professions is a crucial and essential component to delivering competent care. All of these service activities are designed to develop and support infrastructure for the future workforce. These diversification efforts are necessary to improving health outcome for women of color and achieving reductions in health disparities in reproductive health outcomes.

University Service: I have served in the School of Nursing (SON) as a member of the Recruitment and Retention committee. Our work was focused on the Dean's Diversity Initiative, which began under former Dean David Vlahov. This committee was charged with determining

best practices for faculty recruitment and retention and co-developing training for faculty to improve our diversity efforts. Additionally, I serve as co-Primary Investigator, with Dr. Audrey Lyndon, on a grant to support the development of a UC - Historically Black Colleges and University (HBCU) partnership. This project is focused on developing a pipeline program for Howard University undergraduates to participate in summer intensives with UCSF SON faculty and to ultimately apply to UC PhD programs in Nursing. In the Fall of 2018, I became the departmental representative to the PhD Admissions and Screening Committee.

I currently serve a collaborating faculty member and mentor to the San Francisco Building Infrastructure Leading to Diversity (SF Build) program led by Dr. Kirsten Bibbins-Domingo (UCSF) and Dr. Leticia Magana (San Francisco State University; SFSU). SF Build is an NIH funded program to develop students of color within science, technology, engineering and math (STEM) programs. As part of the SF Build program, I serve as a faculty-affiliate and co-investigator with the Social Innovation and Urban Opportunity Lab (SOUL) led by Dr. Antwi Akom (SFSU).

In 2002, I participated in the NIH-NCI funded Minority Training Program in Cancer Control Research and Health Disparities (MTPCCR), a pipeline program to increase the number of underrepresented minorities in PhD programs. I successfully completed this program and for the last 14 years, I have served as a senior mentor to new participants. I have hired interns from this program (Ms. Zakeya Warner Hand, 2013 and Ms. Tijen Sumbul, 2016) who I teach research skills and support in distinct projects. I have published a manuscript with Ms. Warner Hand and am currently revising a manuscript with Ms. Sumbul for publication.

In 2018, I was asked by Vice Chancellor and Dean of the Graduate Division, Dr. Elizabeth Watkins to participate in the UCSF Alumni Weekend Discovery Talks where I share my work in a talk entitled: **What is Reproductive Justice? And Why Is It Needed?**

Board Service: I currently serve on four boards. First, Centering Healthcare International, an organization that has a mission to make Centering group healthcare available globally focusing on mothers and babies. This model has been shown to improve birth outcomes for low-income and women of color and is an important component to achieving necessary changes to healthcare service provision. Second, Trauma-Informed Schools Learning Network, led by Dr. Monique Morris. Third, I also serve as a senior scientist on a project led by Dr. Lisa H. Harris at the University of Michigan entitled: Evidence Based Story Telling, and finally, I serve as a senior adviser to the California, Home Abortion by Telemedicine (CHAT) study led by Dr. Ushma Upadhyay.

Community Service: I currently serve as a scientific consultant and founding board member to the Roots of Labor Birth Collective and have been in this role since 2013. This collective of doulas of color that is fiscally sponsored by Haven of Hope LLC, provides low-cost or no-cost doula support across labor, birth, and postpartum to birthing people who need them most, low-income and women of color.

CONTRIBUTIONS TO DIVERSITY

Historically, I actively participated in the SON Diversity in Action (DIVA) committee and took a hiatus for the 2017-2018 academic year. Additionally, in the School of Medicine, I serve on the Differences Matter Initiative and have been assigned to working on objective 3.1 - Defining Core Competencies for Students. My scholarly work, teaching, and research are informed by my experiences as a person of color. This status affords me multiple opportunities to participate in diversity activities as a speaker, participant, consultant, and collaborator. I am a

highly consulted scholar given my deep knowledge of the intersections of race and how it intersects with health service delivery, specifically to highly stigmatized areas of women's reproductive health. Given the dearth of scholars of color throughout UCSF and more specifically in the school of nursing, I am a well networked faculty member who seeks to create opportunities for the other scholars of color at UCSF. I am mentor or co-mentor to 9 students of color in the school of medicine and nursing in addition to 2 faculty in both schools. I also mentor underrepresented minority scholars at 3 other universities who are interested in reproductive justice approaches in their scholarly work.

TEACHING AND MENTORING

TEACHING SUMMARY

SON Teaching: My teaching is grounded in my clinical and research expertise. For the past eight years, I have served as Faculty of Record (FOR) for N259.04 Contraception in Primary Care. This course is one of the most subscribed courses at UCSF and is taken by students from the schools of nursing, medicine and pharmacy. This course averages 80 students in the fall and 25 in the spring. It includes online and in person sessions. This course is both a pharmacology and epidemiologic course, specifically designed for clinicians and researchers. It is part of the core courses for midwifery and family nurse practitioner students. I have continued to teach N259.04 Contraception in Primary Care and added an additional optional unit this quarter to cover topics essential to understanding the context that contraception is provided including professional ethics and reproductive justice, patient autonomy and shared decision making, intimate partner violence, sex trafficking, pregnancy diagnosis and options counseling. In 2017, the teaching assistants and I embarked on a major course overhaul including the addition of an optional unit that allowed students deeper readings into important contemporary topics, such as sex trafficking, care of sex workers, and reproductive coercion.

I have also continued to serve as faculty of record for OB/GYN 170.03 Reproductive Health Elective. I have created educational modules for the UCSF and broader reproductive health, rights, and justice field with the Innovating Education in Reproductive Health program (Innovating Education in Reproductive Health Course - Abortion Reversal).

PhD Program Teaching: In 2016, I was co-FOR for N223B Research Seminar in Symptom Management: Interventions and Outcomes with Dr. Linda Franck. There were 11 students (7 predoctoral and 4 postdoctoral) in the course. I served as a mentor for the students and assisted 2 students in developing proposals for funding from this seminar, one of which was funded by Sigma Theta Tau, International, the Honor Society in Nursing (student Kyung Mi Kim). Finally, I served as co-faculty of record for N209A Qualitative Research Methods with Dr. Kit Chesla - a course I now lead.

Co-Faculty of Record: N248 Clinical Issues in Global Maternal Health is a new course co-developed by me and midwifery faculty (Deena Mallreddy, and Kim Dau) that is being offered for the first time in Spring, 2017. I currently serve as co-faculty of record for the 5-week group independent study that we hope to develop into a joint seminar with Global Health Sciences faculty. We currently have 7 enrolled students. Exposing students to global maternal health during their educational training, provides opportunities to develop proposals and projects that will enhance their clinical skills. One student, as a result of assisting me to prepare for this course has been named a Global Health Pathways to Discovery Clinical Scholar (student – Tenley Spatz).

Interprofessional Teaching: For the past five years, I have been co-FOR with Dr. Jody Steinauer in OB/GYN, of OB/GYN 170.0 Family Planning and Reproductive Health Seminar. This course is coordinated by the Nursing, Medicine, and Pharmacy Students for Choice and provides a broad overview of family planning and reproductive health in both global and local contexts and includes advocacy, policy, clinical care provision, and hands-on skills/training. On average 68 students participate in this weekly seminar from medicine, nursing, and pharmacy. I contextualize the role of nurses at both the RN and APC levels in reproductive health and lead the portions of the course that are embedded in nursing.

I provide access to both courses to UCSF faculty in Epi/Biostats, Sociology, Family and Community Medicine and Obstetrics and Gynecology, as well as across the departments in the School of Nursing.

Guest Lectures: Given my work in public health, nursing, and my focus on women's reproductive health and justice, I am a highly sought after guest lecturer. I have provided guest lectures for the last 11 years in N265 Cancer Prevention and Early Detection, for the last 8 in N147 Childbearing Families, and lectures in N240.02 Biomarkers, N294A Introduction to Human Genomics, S210 Proseminar in Health Policy, N260 Global Health Policy and Nursing and multiple sessions for the Bixby Center for Global Reproductive Health.

MENTORING SUMMARY

I currently serve as primary mentor/advisor to 6 master's students. I also am serving on the qualifying exam committee for 2 predoctoral students, Renee Smith (member) and Norlissa Cooper (chair). In 2017, I chaired the qualifying exam committee for Nicholas Rubashkin (GHS). I served as a master's thesis committee member for a midwifery student, Elle Trainor, and I was primary mentor to Tenley Spatz (midwifery student), who was selected to participate in the 2017 Graduate Medical Education cohort of the Global Health (Clinical Scholars) Pathways to Discovery Program. Additionally, I have 3 students currently completing masters theses: 1) Brittany Edwards - Experiences of pregnancy and birth for men of color who are partners to women at social and/or medical risk for preterm birth; 2) Katie Millar - Prevalence, predictors, and outcomes of maternal mental health disturbances in post-conflict Rwanda: Implications for midwifery policy and practice; and I'm chairing the thesis for Signy Toquinio - Women's perspectives on substance use screening in perinatal care.

I currently serve a co-mentor for two physicians who are fellows in family planning. Dr. Katherine Brown at UCSF and Dr. Wendy Leung at Yale. Both are using qualitative research methods to understand Black women's experiences of abortion (Brown) and nursing students' conceptualization of their role in abortion care (Leung).

Dr. Karen Scott is a board certified OB/GYN, friend, and physician colleague who sought me out as a mentor as a scholar of color and given my work in women's reproductive health and justice. Dr. Scott is finishing her MPH work in applied epidemiology Emory University and is pursuing a thesis project that is focused on preterm birth, migration patterns and diabetes in California using the big data resource maintained by Dr. Laura Jeliffe-Pawlowski, Director for Discovery for the California, Preterm Birth Initiative. I was a member of her thesis committee and she is now adjunct faculty in the Family Health Care Nursing Department in the School of Nursing at UCSF.

Dr. Brittany Chambers completed a 1-year postdoctoral fellowship with the California, Preterm Birth Initiative and I served as co-mentor to Dr. Chambers with Dr. Jeliffe-Pawlowski. Dr. Chambers successfully competed for a Bridging Interdisciplinary Research Careers in Women's Health (BIRCWH) K-award and I will be continuing to serve as one of her mentors as she transitions to her new role as an Assistant Adjunct Professor in the Department of Epidemiology and Biostatistics at UCSF.

Dr. Kate Minihan-Coleman is a family nurse practitioner who completed a postdoctoral fellowship with Dr. Dan Grossman, Director of ANSIRH as part of his project evaluating women's reproductive health legislation in Texas. She is currently an assistant professor at University of Colorado, Denver with Dr. Nancy Lowe as her faculty mentor. I am working with Dr. Minihan-Coleman who is building a program of research in women's reproductive health care, specific to post abortion and post partum access to long acting reversible contraception.

RESEARCH AND CREATIVE ACTIVITIES

RESEARCH AND CREATIVE ACTIVITIES SUMMARY

My program of research is focused on understanding the factors that influence the health, wellbeing and livelihood of low-income and women of color. Using the intersectional human rights middle range theory called reproductive Justice (RJ), enables me to design rigorous studies that answer novel and complex research questions because RJ is simultaneously a theory, practice and a strategy that is grounded in four principles. Simply put, RJ posits that every person has the right to decide if and when to become pregnant and to determine the conditions under which they will birth. Next, every person has the right to decide they will not become pregnant or have a baby and options for preventing or ending pregnancy are accessible and available. Third, individuals have the right parent children they already have with dignity and has the necessary social supports in safe environments and health communities without fear of violence from individuals or the government. Finally, individuals have the right to disassociate sex from reproduction and that health sexuality and pleasure are essential components to whole and full human life.

I have had steady funding for my research studies across the reproductive spectrum informed by the four principles of RJ. I have leveraged small intramural grants through the UCSF School of Nursing research program and the resource allocation program (RAP) to map where nurses intersect with patients and the public who seek reproductive health and how nurses conceptualize the provision of ethically challenging care, including abortion. These studies show that nurses engage in complex process of decision-making that we named calculus formation and that there are multiple ways they determine when, where, and how to provide

clinical care. Nurses thickly described holding a tension of opposites between their personal beliefs and professional responsibilities. Three peer reviewed papers resulted from this work. I was named a fellow of the Hellman Family Fund in 2015, which supported me to collect pilot data for one of the largest cohort studies of Black and Brown women to understand the complex interplay of stress, resilience, and coping across multiple time points during pregnancy (Saving Our Ladies from early births And Reducing Stress study). These data show that highly stressed women exhibit both coping and resilience and that racism and experiences of discrimination are the primary stressors in their lives. This work positioned me to gain new funding to lead the SOLARS feasibility study on behalf of the UCSF Preterm Birth Initiative (UCSF PTBi) as part of their discovery work to unlock both the molecular and social aspects that influence preterm birth. We are preparing these data for peer review. The next phase of SOLARS - a full 1,000-woman cohort study - will be led by Dr. Brittany Chambers who I successfully mentored during a yearlong postdoc funded by the UCSF PTBi who was recently awarded the prestigious UCSF/Kaiser Bridging Interdisciplinary Research Careers in Women's Health (BIRCWH) K-scholars fellowship.

The extramural funding that supports my program of research has consisted of five large grants, two from the Alameda County Public Health Department (TOTAL: \$236,305), and three from the Susan T. Buffett Foundation (Total: \$1,859,313). In partnership with community-based doulas, I designed and tested doula work as a vocational job training program to determine if this would reduce recidivism for low-income and women of color who experienced incarceration. To this day and to our knowledge none of the participants in the Roots of Labor Birth Collective have returned to jail, most continue to care for pregnant people across the Bay Area and many serve as collaborators with UCSF PTBi and other affiliated projects. Funds from the Buffett foundation have afforded me the opportunity to build upon the data I collected using the small intramural grants to conduct a California statewide survey of nurses (n=504) to understand their attitudes and beliefs toward sexual and reproductive health and abortion care provision. These crucial data along with a similar national survey I conducted with the membership of the Association of Women's Health, Obstetric, and Neonatal Nursing (AWHONN) yielded 2,000 responses from nurses and provides the most current and accurate data that reflect nurse attitudes and perceived competence to provide pregnancy options counseling including the provision of fact-based information about abortion, contraception, adoption and parenting. Findings from these studies are under peer review. Additionally, I was recently awarded a \$1.4 million dollar 3-year grant to develop the Abortion Care Training Incubator of Outstanding Nurse Scholars (ACTIONS) program that will fund pre- and postdoctoral scholars within the existing UCSF Health Policy PhD program.

I have used multiple methods to disseminate my scientific findings, including the production of 21 highly cited, peer reviewed manuscripts since the time of successful dissertation defense. I have also written 18 OpEds, commentaries, or blog posts to explain my research findings to the public and contextualize my work. I have appeared on billboards, social media campaigns and in popular media/press including the BBC, National Public Radio (NPR), Colorlines, PopSugar, Dame Magazine, The Sacramento Bee, the Examiner, Ms. Magazine Blog, Time Magazine, and have recorded my work for Christy Turlington Burns' Every Mother Counts documentary series Birthing in America and for the Terrance Nance's HBO series entitled Random Acts of Flyness. My research findings have been cited in two amicus briefs to the Supreme Court of the United States (i.e., Whole Women's Health vs. Hellerstedt in 2015 and NIFLA vs. Becerra in 2018). Additionally, my research findings were also cited in the recent report from the National Academies of Science, Engineering and Medicine entitled The Safety and Quality of Abortion in the United States (2018). Finally, I currently am serving as co-Editor for 2 books, I have 4 manuscripts currently under peer review, 2 OpEds ready to be pitched for

publication regarding the NIFLA vs. Becerra SCOTUS decision & NASEM report. I have 2 papers with revise and resubmit decisions and 6 additional manuscripts in draft form to further disseminate my research findings for use in clinical practice and public health.

The goal was to directly involve these women in identifying and prioritizing their unanswered questions about pregnancy, birth and neonatal care, and treatment so that their views could be included in research priority setting by funders and researchers.

This work served as foundational data to contextualize the work and drew the attention of the Peabody award winning work of Renee Montagne (NPR) and Nina Martin (ProPublica) that earned them a spot as a finalist for the Pulitzer Prize award in investigative reporting.
