Change Healthcare provides services under contracts with several federal government agencies, including:

- The Department of Defense
- The Department of Health & Human Services
- The Department of Veterans Affairs

There are approximately 16 larger prime contracts, and approximately 122 smaller contracts. Change Healthcare also offers services to federal agencies under a General Services Administration Federal Supply Schedule contract.

We understand the subject matter of the hearing to be the cyberattack on Change Healthcare. Change Healthcare's contracts with federal government agencies include technology and clinical tools licensing agreements, as well as contracts for network, payment, imaging, clinical, and other health services provided by Change Healthcare to these customers. Change Healthcare provides services under contract with the following foreign government health authorities:

- Multiple territorial health authorities in Australia
- Multiple provincial health authorities in Canada
- The Health Service Executive for the Republic of Ireland
- The Israeli National Innovation Technical Authority
- The National Guard Health Authority for the Kingdom of Saudi Arabia
- Multiple trusts (hospitals) that are part of the United Kingdom National Health Service
