William M. Mohl President – Entergy Wholesale Commodities Entergy Corporation

Bill Mohl has held numerous leadership positions with several different energy companies over the past 31 years, and recently was promoted to the role of President of Entergy Wholesale Commodities, headquartered in White Plains, New York, with responsibility for Entergy's unregulated wholesale power business comprised of approximately 5,000 MW of merchant nuclear generation (primarily located in the Northeastern U.S.) and 1,000 MW of fossil and renewable generation resources. Prior to this role, Mr. Mohl served as the Chairman, President and CEO of Entergy Louisiana, LLC and Entergy Gulf States, LLC from 2010-2013, a role in which he was responsible for all financial, operational and regulatory results associated with these utilities as well as the natural gas distribution businesses in Baton Rouge and New Orleans, LA.
