Thank you for agreeing to testify on Tuesday, July 23, 2013, at 9:45 a.m. in 2123 Rayburn House Office Building, at the Subcommittee on Energy and Power hearing entitled "Overview of the Renewable Fuel Standard: Stakeholder Perspectives."

In this Subcommittee's June 26, 2013, hearing entitled "Overview of the Renewable Fuel Standard – Government Perspectives," the Environmental Protection Agency, Energy Information Administration, and Department of Agriculture all concurred that the RFS faces near-term implementation challenges, particularly in 2014. In addition, many commenters to the Committee's white paper series on the RFS noted these challenges.

You are scheduled to testify on the second panel, which will address fuel sales and use issues – the economic, technological, and other challenges of introducing RFS-compliant fuels into the stream of commerce, including the impacts on end users.

The purpose of this hearing is to solicit stakeholder input on the current status of RFS implementation, with a particular focus on potential modifications to the program that would help avert emerging problems and maintain its long-term viability. Please address these potential modifications in your testimony.


