BIOGRAPHY

Mel Coleman, Chief Executive Officer North Arkansas Electric Cooperative

Mel Coleman joined North Arkansas Electric Cooperative in 1988 as Manager of Member Services. After 10 years, he was promoted to serve as the cooperative's Assistant General Manager. In January 2001, he was promoted to his current position as CEO of North Arkansas Electric Cooperative.

Mel is a board member and currently serves as Chairman of the Board for both Arkansas Electric Cooperative Corp. (AECC) and Arkansas Electric Cooperatives, Inc. (AECI) which are based in Little Rock.

In 2003, Mel was elected to represent Arkansas' 17 electric distribution cooperatives on the board of directors of the National Rural Electric Cooperative Association. In 2011 he was elected secretary-treasurer of the NRECA Board and in 2013 he was elected vice-president. Mel also serves on the Board of Directors of National Rural Utilities Cooperative Finance Corporation.

A native of Pocahontas, Ark., Mel settled in Salem after completing his studies at Arkansas State University in Jonesboro. His early career from 1976 through 1987 was in the field of radio and television, and was followed by a brief tenure with the Bank of Salem before assuming his duties at North Arkansas Electric Cooperative.

He is a past president and past board member of the Salem Chamber of Commerce and served on the Fulton County Quorum Court for 18 years. Coleman currently serves on the development council of ASU-Mountain Home and was one of six Arkansas delegates to the 1995 White House Conference on Small Business. Mel has served on numerous NRECA national panels as a planning committee member and as a conference speaker. He has also served on the ERMCO board.

For more than 25 years, Mel has served the members of North Arkansas Electric Cooperative which provides power to nearly 36,000 meters and has more than 4,800 miles of line in parts of eight counties in northern Arkansas. The cooperative was incorporated on March 21, 1939.
