Ms. Martinez is President and co-founder of Hispanics in Energy, a non-partisan, non-profit organization dedicated to providing a platform for Hispanics and energy. Hispanics in Energy promotes economic development in energy through career awareness and supplier engagement. In addition, it focuses on promoting science, technology, engineering and science amongst students.
