Brian H. Lloyd Executive Director Public Utility Commission of Texas

Brian H. Lloyd joined the Public Utility Commission as Executive Director on December 1, 2010. As Executive Director, Mr. Lloyd oversees the day-to-day operations and management of the PUC including directing key programs such as development of the agency's strategic plan, direction of staff analysis of contested proceedings and rulemakings, and development and implementation of the agency's budget. Mr. Lloyd also coordinates the agency's interaction with other state agencies, and represents the agency at the Texas Legislature and other forums.

From 2008 to 2010, Mr. Lloyd served as Deputy Director of Budget, Planning and Policy for Governor Rick Perry, where he assisted with the management of the Governor's advisors, coordinated policy development, and oversaw development of state agency budget instructions and strategic planning. Mr. Lloyd also served as the lead energy and utility policy advisor to the Governor, including leading analyses of environmental policy impacts on the state's energy markets.

Over a 19 year career, Mr. Lloyd has served in roles of increasing responsibility in the areas of electricity and telecommunications market design, restructuring, and deregulation, as well as areas of electric reliability and assessing the impacts of federal environmental policy on competitive and regulated electricity markets. Mr. Lloyd has worked at a variety of capacities at the PUC and private industry spearheading major initiatives including overseeing the transition to competition of the retail electric industry. He was the primary author of the 2008 Texas State Energy Plan, authored numerous agency reports to the Texas Legislature, and has provided testimony before legislative committees, the Federal Energy Regulatory Commission (FERC), federal courts, and the PUC on issues of electric reliability, electricity markets, utility ratemaking policies, and other matters related to the utility industry.

Mr. Lloyd earned a bachelor's degree in economics at Louisiana State University and graduated from the University of Texas at Austin with a master's degree in economics. He serves an exofficio member of the Texas Commission on State Emergency Communications and as a member of the Texas Restore Act Advisory Board.
