Alex Glenn is senior vice president of state and federal regulatory legal support for Duke Energy. Partnering with the company's corporate and regulatory strategy team and state presidents, he is responsible for advancing rate and regulatory initiatives throughout the enterprise and updating regulatory models. In addition, his team provides legal advice on state and federal regulatory matters.

Before assuming his current position in January 2017, Glenn served as state president of Duke Energy's utility operations in Florida, serving approximately 1.7 million electric retail customers in central Florida, including metropolitan St. Petersburg, Clearwater and the Greater Orlando area. He was responsible for advancing the company's rate and regulatory initiatives and managing state and local regulatory and governmental relations, economic development and community affairs. He served in that role since December 2012.

Glenn has been with Duke Energy (and predecessor companies Progress Energy and Florida Power Corp.) since 1996, and served in various leadership positions. In a previous role as general counsel for the Florida utility operations, which he assumed in 2008, Glenn oversaw all regulatory matters affecting the Florida utility. In addition, he served as a key advisor to the Florida state president, as well as other company executive management and the board of directors.

Before joining the company, Glenn practiced energy law at the international law firm of Morgan, Lewis & Bockius LLP in Washington, D.C.

Glenn earned a bachelor's degree, magna cum laude and Phi Beta Kappa, and law degree, with honors, from the University of Connecticut. He is a member of the Connecticut, Washington, D.C., and Florida bars.

He serves on the boards of the Florida Chamber of Commerce, Enterprise Florida, St. Petersburg Chamber of Commerce and the Pinellas Education Foundation. He is also a resident member of the Florida Council of 100. He has served on the board of the Boys and Girls Club of the Suncoast, and is a 2011 graduate of the Leadership Florida Class XXIX and the Leadership St. Petersburg Class of 2004.

Glenn and his wife, Robin, have three sons.
