The Subcommittee on Energy will meet in OPEN MARKUP SESSION at **10 a.m.** on Thursday, May 16, 2019, in the John D. Dingell Room, 2123 of the Rayburn House Office Building, and subsequent days as necessary, to consider the following legislation:

1. **H.R. 2088**, a bill to amend the Energy Independence and Security Act of 2007 to reauthorize the Energy Efficiency and Conservation Block Grant Program, and for other purposes;
2. **H.R. 2041**, the “Weatherization Enhancement and Local Energy Efficiency Investment and Accountability Act”;
3. **H.R. 2119**, a bill to amend the Energy Policy Act of 2005 to reauthorize grants for improving the energy efficiency of public buildings, and for other purposes;
4. **H.R. 1315**, the “Blue Collar to Green Collar Jobs Development Act of 2019”;
5. **H.R. 2665**, the “Smart Energy and Water Efficiency Act of 2019”;
6. **H.R. 2044**, the “Smart Building Acceleration Act”;
7. **H.R. 359**, the “Enhancing Grid Security through Public-Private Partnerships Act”;
8. **H.R. 360**, the “Cyber Sense Act of 2019”;
9. **H.R. 362**, the “Energy Emergency Leadership Act”; and
10. **H.R. 370**, the “Pipeline and LNG Facility Cybersecurity Preparedness Act”

The staff briefing for the markup will be held on Wednesday, May 15, 2019, at 3:30 p.m. in room 2123 of the Rayburn House Office Building.
