**SUBJECT: Subcommittee Hearing on “The CLEAN Future Act: Driving Decarbonization of the Transportation Sector”**

The Subcommittee on Energy of the Committee on Energy and Commerce will hold a virtual, fully remote hearing on **Wednesday, May 5, 2021, at 11:30 a.m. (EDT)**. The hearing is entitled, “The CLEAN Future Act: Driving Decarbonization of the Transportation Sector.” Witnesses will be by invitation only.

This is a legislative hearing that will focus on the following attached bills:

- **H.R. 1512**, the “Climate Leadership and Environmental Action for our Nation’s Future Act” or the “CLEAN Future Act” (*Reps. Pallone (D-NJ), Tonko (D-NY), and Rush (D-IL) on 03/02/2021*)
- **H.R. 2852**, the “NO EXHAUST Act” (*Rep. Rush on 04/26/2021*)
- **H.R. 1221**, the “Electric Vehicles for Underserved Communities Act of 2021” (*Rep. Clarke (D-NY) on 02/23/2021*)
- **H.R. 2308**, the “Advanced Technology Vehicles Manufacturing Future Act of 2021” or the “ATVM Future Act” (*Rep. Dingell (D-MI) on 04/01/2021*)

This hearing will be held using Cisco WebEx online video conferencing. Members will receive WebEx participant access information by email before the hearing. One staffer from each member’s office may join this remote hearing as an attendee. Each designated staff attendee must **register** at the provided link **by no later than Tuesday, May 4, 2021, at 12 p.m. (EDT)**.
