Infrastructure, Efficiency, and Financing"

The Subcommittee on Energy of the Committee on Energy and Commerce will hold a hybrid hearing that includes both in-person and remote attendance on **Wednesday**, **June 22**, **2022**, **at 10:30 a.m.** (**EDT**). The hearing is entitled, "Legislative Hearing to Strengthen Energy Infrastructure, Efficiency, and Financing." Witnesses will be by invitation only.

This is a legislative hearing that will focus on the following attached bills:

- **H.R. 5292**, the "Energy Accountability Act" (*Rep. Young (R-AK) on 09/17/21*)
- **H.R. 7947**, the "Weatherization Enhancement and Readiness Act of 2022" (*Reps. Tonko (D-NY)*, *Rush (D-IL)*, and *Kaptur (D-OH)* on 06/03/2022)
- **H.R. 7962**, "To amend the Energy Policy and Conservation Act to modify the definition of water heater under energy conservation standards, and for other purposes" (*Rep. Dingell (D-MI) and 11 original bipartisan cosponsors on 06/04/2022*)
- **H.R. 8053**, the "Guaranteeing Resilient Installations for Defense Act" or the "GRID Act" (*Reps. Crow (D-CO), Peters (D-CA), and Bacon (R-NE) on 06/14/2022*)
- **H.R. 8068**, the "Tribal Energy Investment Act of 2022" (*Reps. Leger Fernández (D-NM)*, *O'Halleran (D-AZ)*, *Cole (R-OK)*, and *Davids (D-KS) on 06/15/2022*)

This hearing will take place in the John D. Dingell Room, 2123 of the Rayburn House Office Building, as well as remotely using Cisco Webex online video conferencing. Members will receive Webex participant access information by email before the hearing. No staff from member offices will be allowed in the Committee room. However, one staffer from each member's office may join the hearing remotely as an attendee. Each designated staff attendee must register at the provided link by

no later than Tuesday, June 21, 2022, at 12 p.m. (EDT). The public may view this hearing via live webcast on the Committee's website: http://energycommerce.house.gov.

For members planning to attend in person, the Committee notes that this hearing is being held during the COVID-19 pandemic, therefore the Committee will adhere to the greatest extent possible to the safety guidelines issued by the Centers for Disease Control and Prevention and the Attending Physician of the Capitol. **Guidelines regarding the conduct of this hearing were previously distributed.**

The Democratic staff briefing will be held immediately following the bipartisan briefing. The Republican staff briefing will be announced separately.
