### **Biography:**

Dr Catizone is the Executive Director of the National Association of Boards of Pharmacy® (NABP®) and the Secretary of the Association's Executive Committee. NABP is an international organization whose membership includes the state boards of pharmacy in all 50 United States, the District of Columbia, Guam, Puerto Rico, the Virgin Islands, Australia, New Zealand, and eight provincial pharmacy regulating agencies in Canada<sup>1</sup>.

The purpose of NABP is to: (1) assist the state boards of pharmacy in protecting the public health and welfare, (2) serve as an information and disciplinary clearinghouse for the interstate transfer of licensing among the state boards of pharmacy, and (3) provide model regulations in order to assist the state boards of pharmacy with the development of uniform practice, educational, and competency standards for the practice of pharmacy.

Dr Catizone graduated from the University of Illinois at Chicago, College of Pharmacy, with a Bachelor of Science degree in pharmacy and a Master of Science degree in pharmacy administration. His master's studies focused on health care policy/planning and the history of pharmacy. He currently serves as a Governor of the Pharmacy Technician Certification Board (PTCB) Board of Directors and Chair of the PTCB Certification Council. He is a Past President of the National Pharmacy Manpower Project and the National Conference of Pharmaceutical Organizations (NCPO) as well as a past member of the United States Pharmacopeia (USP) Board of Directors. He has also acted as a reviewer on several advisory boards and has provided expert witness testimony and consultation in the areas of pharmacy practice and regulation.
