BRAINSTEPS CHILD & ADOLESCENT BRAIN INJURY SCHOOL RE-ENTRY PROGRAM 2007-present

Funded by the PA Department of Health under contract with the Brain Injury Association of Pennsylvania, and conducted in partnership with the PA Department of Education.

Authored grant application that was funded at \$175,000 per year to support this program, which works to ensure that those who provide educational support to children with brain injury have a comprehensive understanding of the effects of brain injury, the resulting challenges, and supports and interventions that will help these students achieve educational success throughout their school career. Involves collaboration between school personnel, medical rehabilitation professionals, community and family supports.

WIDENER WORKS 2007-2009

Funded by the Pennsylvania Department of Labor's Office of Vocational Rehabilitation.

Served as Administrator/Rehab Psychologist on this joint venture between the Philadelphia School District's Widener Memorial School, OVR, and The Children's Hospital of Philadelphia's Office on Diversity and Inclusion.

This project utilizes rehabilitation technologies in a supported employment model to provide job exploration, job simulation, job trials, job development, and job placement for some of the District's most severely disabled youth. The Rehab team conducts a functional skills analysis using real life job scenarios, and develops with the client a vocational direction, which is then tested out through a series of volunteer job trials using real department settings within the hospital under the guidance of a job coach. Developed into fee for service agreement which will now be able to serve any Philadelphia School District student with a severe disability, nearing graduation.

EFFECTIVENESS AND TOLERABILITY OF MODIFIED CONSTRAINT –INDUCED MOVEMENT IN CHILDREN WITH STROKE 2007-2009

Funded by the Women's Committee of The Children's Hospital of Philadelphia.

Served as Co-Investigator on this IRB approved clinical research pilot project for children with hemiparesis secondary to stroke, the purpose of which is to refine massed practice procedures in a modified protocol of Constraint Induced Movement Therapy, to prepare for a larger scale study to demonstrate the extent to which these methodologies can be applied and made practical for families with children, to be carried out in after school therapies, and still demonstrate improvement of upper limb functionality.

BRAIN INJURY EDUCATION AND TRAINING PROGRAM 2007-2009

Funded by the PA Department of Health under contract with the Brain Injury Association of Pennsylvania.

Authored grant application that was funded at \$101,250 per year to support this program, which provided training and education to groups of people who may be the first to come into contact with a person with a mild brain injury, who may not be hospitalized. Target groups included Emergency Room and Trauma Center staff, School Nurses, Mental Health Professionals, Police, and Clergy.

CHILD EVALUATION CENTER/FETAL ALCOHOL DIAGNOSTIC CLINIC 2007-2009

Funded by Health Service Grant from New Jersey Department of Health and Senior Services, Special Child, Adult, and Early Intervention Services Division.

3 year grant provides an interdisciplinary approach to evaluating children with developmental, behavioral, and learning disabilities. These children with special health care needs, such as Autistic Spectrum Disorder, Down Syndrome, cerebral palsy, Spina bifida, muscular dystrophy, mental retardation, early childhood development delays, feeding and swallowing difficulties, attention deficit and hyperactivity disorders, and acquired brain injuries, may not be well served in the regular pediatric healthcare system. Center seeks to define their special health care needs and assure appropriate treatment, intervention, and coordination of care across systems.

PRE-ENROLLMENT ASSISTANCE COORDINATION 2004-present

Funded by the PA Department of Health under contract with the Brain Injury Association of Pennsylvania.

Authored grant application that was funded initially at \$50,000 per year, recently expanded to \$150,000 per year. Hired, trained and coordinated a staff of highly experienced brain injury clinical care coordinators covering the entire Commonwealth to evaluate needs of persons with brain injury, meet with them in their homes, and develop plans of care and establish access to resource systems and rehabilitation providers. Program has evaluated over 1,000 applicants since inception, and is currently planning to pilot NeuroResource Facilitation, which would make this type of assistance available as needed over lifetime and facilitate building networks of natural supports.
