#### **Profile**

Marilyn Moon, Ph.D. is an Institute Fellow at AIR and director of its new Center on Aging. From 2003 through 2013, she directed the Health Program at the American Institutes for Research. Her current work focuses on the role of informing consumers, providers and policy makers about health care issues, issues in delivery system innovations, and approaches to Medicare reform. A nationally-known economist and expert on Medicare, aging, consumer health issues, and health care financing, Dr. Moon has also served as a senior fellow at the Urban Institute and as a public trustee for the Social Security and Medicare trust funds. From 2008 through 2012, she chaired the Maryland Health Care Commission, an independent group that advises state government and produces key reports and analysis for Maryland. She has written extensively on health policy, reform issues in Medicare health financing, and other social insurance issues. She has been an associate professor of economics at the University of Wisconsin, Milwaukee, a senior analyst at the Congressional Budget Office, and the founding director of the Public Policy Institute of the American Association of Retired Persons. Her work has focused on health care financing and public policy issues with a particular emphasis on Medicare cost of health care and its impact on access to care. She has served on a number of boards for non-profit organizations, including the Medicare Rights Center and the National Academy of Social Insurance. She is a member of the Institute of Medicine. Dr. Moon earned a Ph.D. in economics from the University of Wisconsin-Madison.
