As a nonprofit professional with over 21 years of experience I can attest to my knowledge, skills and commitment to not only this program but more importantly this cause.

I have an established background in nonprofit leadership, management, community relations and operations with demonstrated ability to work in diverse environments and make an immediate, positive impact within organizations. This program focuses on the engagement of community based organizations to reach out through networks to find those that are underserved in order to get them into quality care. I have a proven record of identifying and advancing effective community outreach programs, advocacy initiatives, key partnerships and fundraising initiatives. All skills required to provide effective leadership to this program and sustain it after two years. In one of my prior positions I was able to engage through coalition building a solid group of over 100 stakeholders to partner with the program. As a result the program achieved 98% success with the clients graduating and obtaining gainful employment. In addition to this role I served as Community Services and Outreach Director for a five-county health system. Under my leadership and through collaboration with key leaders the system opened its second indigent care clinic, implemented a state-wide Hispanic Lay Promoter to increase the number of individuals to get mammograms and prostate examinations (for those underserved) and develop a one certificate program (Jeremiah's Hope) into a certification training school for over 10 new areas of profession. All of these accomplishments were made possible through grassroots strategy and unification.
