7 "(B) IDENTIFICATION OF DNA MATCH ON 8 CLAIM.—The Secretary shall require an indica-9 tion on a claim for a DNA Specimen Prove-10 nance Assay clinical diagnostic laboratory test 11 of whether the DNA of the prostate biopsy 12 specimen for such test matches the DNA of the 13 individual with respect to whom the test was or-14 dered. 19 "(A) IN GENERAL.—The Secretary shall 20 review at least three years of claims under part 21 B for DNA Specimen Provenance Assay clinical 22 diagnostic laboratory tests to identify whether 23 the DNA of the prostate biopsy specimens for 24 such tests matched the DNA of the individuals 25 with respect to whom such tests were ordered.

1 "(B) POSTING ON INTERNET WEBSITE.— 2 Not later than July 1, 2024, the Secretary shall 3 post on the Internet website of the Centers for Medicare & Medicaid Services the findings of 4 5 the review conducted under subparagraph (A). 6 "(4) DATE SPECIFIED.—For purposes of paragraph (1) and section 1862(a)(1)(Q), the date speci-7 fied in this paragraph is the first day of the second 8 calendar quarter that begins at least 180 days after 9 10 the date of the enactment of this subsection.".
