Amendment drafted to the HEALTHY KIDS Act, October 2, 2017 (8:42 p.m.)

Strike section 203 and insert the following new section:

SEC. 203. NEGOTIATION OF LOWER COVERED PART D DRUG PRICES ON BEHALF OF MEDICARE BENE FICIARIES.

4 (a) NEGOTIATION BY SECRETARY.—Section 1860D–
5 11 of the Social Security Act (42 U.S.C. 1395w–111) is
6 amended by striking subsection (i) (relating to noninter7 ference) and inserting the following:

8 "(i) Negotiation of Lower Drug Prices.—

9 "(1) IN GENERAL.—Notwithstanding any other 10 provision of law, the Secretary shall negotiate with 11 pharmaceutical manufacturers the prices (including 12 discounts, rebates, and other price concessions) that 13 may be charged to PDP sponsors and MA organiza-14 tions for covered part D drugs for part D eligible in-15 dividuals who are enrolled under a prescription drug 16 plan or under an MA–PD plan.

2	FORMULARIES.—
3	"(A) IN GENERAL.—Nothing in paragraph
4	(1) shall be construed to authorize the Sec-
5	retary to establish or require a particular for-

21	"(4) Semi-annual reports to congress.—
22	Not later than June 1, 2018, and every 6 months
23	thereafter, the Secretary shall submit to the Com-
24	mittees on Ways and Means, Energy and Commerce,
25	and Oversight and Government Reform of the House

of Representatives and the Committee on Finance of 1 2 the Senate a report on negotiations conducted by the 3 Secretary to achieve lower prices for Medicare bene-4 ficiaries, and the prices and price discounts achieved by the Secretary as a result of such negotiations.". 5 (b) EFFECTIVE DATE.—The amendment made by 6 7 subsection (a) shall take effect on the date of the enactment of this Act and shall first apply to negotiations and 8 prices for plan years beginning on January 1, 2018. 9
