1 Be it enacted by the Senate and House of Representa-

3 SECTION 1. MEDICARE NOTIFICATIONS TO OUTLIER PRE-

SCRIBERS OF OPIOIDS.

Section 1860D–4(c)(4) of the Social Security Act (42

U.S.C. 1395w-104(c)(4)) is amended by adding at the end

7 the following new paragraph:

1	"(D) OUTLIER PRESCRIBER NOTIFICA-
2	TION.—
3	"(i) Notification.—Beginning not
4	later than January 1, 2020, the Secretary
5	shall, in the case of a prescriber identified
6	by the Secretary under clause (ii) to be an
7	outlier prescriber of opioids, provide, sub-
8	ject to clause (iv), a biannual notification
9	to such prescriber (during the period in
10	which such provider maintains such identi-
11	fication) that such prescriber has been so
12	identified and including such resources on
13	proper prescribing methods and such other
14	information as specified in accordance with
15	clause (iii).
16	"(ii) Identification of outlier
17	PRESCRIBERS OF OPIOIDS.—
18	"(I) In General.—Beginning
19	not later than January 1, 2020, the
20	Secretary shall, using prescriber infor-
21	mation provided by prescriber Na-
22	tional Provider Identifiers included
23	pursuant to subparagraph (A) on
24	claims for covered part D drugs for
25	part D eligible individuals enrolled in

1	prescription drug plans under this
2	part and MA–PD plans under part C
3	and based on the threshold estab-
4	lished under subclause (II), identify
5	prescribers that are outlier opioids
6	prescribers for the most recent 6-
7	month period.
8	"(II) ESTABLISHMENT OF
9	THRESHOLD.—For purposes of sub-
10	clause (I), the Secretary shall, after
11	consultation with stakeholders, estab-
12	lish a threshold, based on prescriber
13	specialty and geographic area, for
14	identifying whether a prescriber in a
15	specialty and geographic area is an
16	outlier prescriber of opioids as com-
17	pared to other prescribers of opioids
18	within such specialty and area.
19	"(iii) Contents of Notification.—
20	The Secretary shall, based on input from
21	stakeholders, specify the resources and
22	other information to be included in notifi-
23	cations provided under clause (i).
24	"(iv) Modifications and expan-
25	SIONS.—

1 "(I) Frequency.—Beginning [5]
2 years after the date of the enactment
of this subparagraph]/[January 1,
4 2025], the Secretary may change the
5 frequency of the notifications de-
6 scribed in clause (i) based on stake-
7 holder input.
8 "(II) Expansion to other
9 PRESCRIPTIONS.—The Secretary may
expand identifications and notifica-
tions under this subparagraph to in-
clude identifications and notifications
with respect to Concurrent prescrip-
tions]/[prescriptions [provided]/
[used] in combination with opioids]
(such as benzodiazepines) that are
17 considered to have adverse side effects
when so used in such combination.".
