## SECTION 1. SHORT TITLE. 2 This Act may be cited as the "Promoting Resources to Expand Vaccination, Education, and New Treatments for HPV Cancers Act of 2021" or the "PREVENT HPV Cancers Act of 2021". 5 SEC. 2. 3	(D) by adding at the end the following:
4	"(E) the importance of recommended vac-
5	cines for prevention of HPV and HPV-associ-
6	ated cancers, including for males;"; and
7	(2) by amending subsection (d) to read as fol-
8	lows:
9	"(d) Johanna's Law.—
10	"(1) National public awareness cam-
11	PAIGN.—
12	"(A) IN GENERAL.—The Secretary shall
13	carry out a national campaign to increase the
14	awareness and knowledge of health care pro-
15	viders and individuals with respect to
16	gynecologic cancers, HPV, and HPV-associated
17	cancers, and the importance of HPV vaccines in
18	preventing HPV and HPV-associated cancers.
19	"(B) Written materials.—Activities
20	under the national campaign under subpara-
21	graph (A) shall include—
22	"(i) maintaining a supply of written
23	materials that provide information to the
24	public on gynecologic cancers, HPV, and
25	HPV-associated cancers; and

1	"(ii) distributing the materials to
2	members of the public upon request.
3	"(C) Public service announce-
4	MENTS.—Activities under the national cam-
5	paign under subparagraph (A) shall, in accord-
6	ance with applicable law and regulations, in-
7	clude publishing materials in digital or print
8	form, public engagement, and developing and
9	placing public service announcements intended
10	to encourage individuals to discuss with their
11	physicians—
12	"(i) their risk of gynecologic cancers
13	and HPV-associated cancers; and
14	"(ii) the importance of HPV vaccines
15	in preventing HPV and HPV-associated
16	cancers.
17	"(D) TARGETED POPULATIONS.—Activities
18	under the national campaign under subpara-
19	graph (A) shall include culturally and linguis-
20	tically competent public service announcements
21	and other forms of communication and public
22	engagement under subparagraph (C) targeted
23	to—
24	"(i) specific higher-risk populations of
25	individuals based on race, ethnicity, level of

1	acculturation, and family history, including
2	African-American and Ashkenazi Jewish
3	individuals;
4	"(ii) communities with high rates of
5	unvaccinated individuals, including males;
6	"(iii) rural communities;
7	"(iv) populations affected by increas-
8	ing rates of oropharynx cancers; and
9	"(v) such other communities as the
10	Secretary determines appropriate.
11	"(2) Consultation.—In carrying out the na-
12	tional campaign under this section, the Secretary
13	shall consult with—
14	"(A) health care providers;
15	"(B) nonprofit organizations (including
16	gynecologic cancer organizations and organiza-
17	tions that represent communities and individ-
18	uals most affected by HPV-associated cancers
19	and low vaccination rates);
20	"(C) State and local public health depart-
21	ments; and
22	"(D) elementary and secondary education
23	organizations and institutions of higher edu-
24	cation.

1	"(3) Demonstration projects regarding
2	OUTREACH AND EDUCATION STRATEGIES.—
3	"(A) IN GENERAL.—
4	"(i) Program.—The Secretary may
5	carry out a program to award grants or
6	contracts to public or nonprofit private en-
7	tities for the purpose of carrying out dem-
8	onstration projects to test, compare, and
9	evaluate different evidence-based outreach
10	and education strategies to increase the
11	awareness and knowledge of women, their
12	families, physicians, nurses, and other key
13	health professionals with respect to
14	gynecologic cancers, including with respect
15	to early warning signs, risk factors, pre-
16	vention, screening, and treatment options.
17	"(ii) Science-based resources.—
18	In making awards under clause (i), the
19	Secretary shall encourage awardees to use
20	science-based resources such as the Inside
21	Knowledge About Gynecologic Cancer edu-
22	cation campaign of the Centers for Disease
23	Control and Prevention.
24	"(B) Preferences in awarding grants
25	OR CONTRACTS.—In making awards under sub-

1	paragraph (A), the Secretary shall give pref-
2	erence to—
3	"(i) applicants with demonstrated ex-
4	pertise in gynecologic cancer education or
5	treatment or in working with groups of
6	women who are at increased risk of
7	gynecologic cancers; and
8	"(ii) applicants that, in the dem-
9	onstration project funded by the grant or
10	contract, will establish linkages between
11	physicians, nurses, other key health profes-
12	sionals, health profession students, hos-
13	pitals, payers, and State health depart-
14	ments.
15	"(C) APPLICATION.—To seek a grant or
16	contract under subparagraph (A), an entity
17	shall submit an application to the Secretary in
18	such form, in such manner, and containing such
19	agreements, assurances, and information as the
20	Secretary determines to be necessary to carry
21	out this paragraph.
22	"(D) CERTAIN REQUIREMENTS.—In mak-
23	ing awards under subparagraph (A), the Sec-
24	retary shall—

1	"(i) make awards, as practicable, to
2	not fewer than five applicants; and
3	"(ii) ensure that information provided
4	through demonstration projects under this
5	paragraph is consistent with the best avail-
6	able medical information.
7	"(E) Report to congress.—Not later
8	than 24 months after the date of the enactment
9	of the PREVENT HPV Cancers Act of 2021,
10	and annually thereafter, the Secretary shall
11	submit to the Committee on Energy and Com-
12	merce of the House of Representatives and the
13	Committee on Health, Education, Labor, and
14	Pensions of the Senate a report that—
15	"(i) summarizes the activities of dem-
16	onstration projects under subparagraph
17	(A);
18	"(ii) evaluates the extent to which the
19	projects were effective in increasing aware-
20	ness and knowledge of risk factors and
21	early warning signs in the populations to
22	which the projects were directed; and
23	"(iii) identifies barriers to early detec-
24	tion and appropriate treatment of such
25	cancers.

1	"(4) Authorization of appropriations.—
2	For the purpose of carrying out this subsection,
3	there is authorized to be appropriated \$25,000,000
4	for the period of fiscal years 2022 through 2026.".
