A BILL

To amend title XIX of the Public Health Service Act to reauthorize the community mental health services block grant program, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as “Community Mental Health
5 Services Block Grant Reauthorization Act”.

1 **SEC. 2. SET-ASIDE FOR EVIDENCE-BASED CRISIS CARE**
2 **SERVICES.**

3 Section 1920 of the Public Health Service Act (42
4 U.S.C. 300x-9) is amended—

5 (1) in subsection (a), by striking
6 “\$532,571,000 for each of fiscal years 2018 through
7 2022” and inserting “\$857,571,000 for each of fis-
8 cal years 2023 through 2027”; and

9 (2) by adding at the end the following:

10 “(d) CRISIS CARE.—

11 “(1) IN GENERAL.—Except as provided in para-
12 graph (3), a State shall expend at least 5 percent of
13 the amount the State receives pursuant to section
14 1911 for each fiscal year to support evidenced-based
15 programs that address the crisis care needs of indi-
16 viduals with serious mental disorders, and children
17 with serious mental and emotional disturbances.

18 “(2) CORE ELEMENTS.—At the discretion of
19 the single State agency responsible for the adminis-
20 tration of the program of the State under a grant
21 under section 1911, funds expended pursuant to
22 paragraph (1) may be used to fund some or all of
23 the core crisis care service components, delivered ac-
24 cording to evidence-based principles, including the
25 following:

26 “(A) Crisis call centers.

1 “(B) 24/7 mobile crisis services.

2 “(C) Crisis stabilization programs offering
3 acute care or subacute care in a hospital or ap-
4 propriately licensed facility, as determined by
5 the Substance Abuse and Mental Health Serv-
6 ices Administration, with referrals to inpatient
7 or outpatient care.

8 “(3) STATE FLEXIBILITY.—In lieu of expending
9 5 percent of the amount the State receives pursuant
10 to section 1911 for a fiscal year to support evidence-
11 based programs as required by paragraph (1), a
12 State may elect to expend not less than 10 percent
13 of such amount to support such programs by the
14 end of two consecutive fiscal years.”.
