Dear Chair Pallone, Ranking Member McMorris Rodgers, Chair Eshoo, and Ranking Member Guthrie,

Community Catalyst appreciates this opportunity to respond to the House Committee on Energy and Commerce's *H.R. 7666 Restoring Hope for Mental Health and Well-Being Act of 2022* released Friday May 6, 2022. Thank you for taking these initial steps forward in developing comprehensive, bipartisan legislation to improve mental health and substance use disorders services across the country. We support H.R. 7666 and offer additional recommendations to make it even stronger.

<u>Community Catalyst</u> is a leading non-profit national health advocacy organization dedicated to advancing a movement for health equity and justice. We partner with local, state and national advocates to leverage and build power so all people can influence decisions that affect their health. Our Program on Substance Use Disorders and Justice-Involved Populations works to advance racial justice by centering community needs, particularly of those most marginalized, and advocating for policy and practice changes to ensure addiction is treated as a health issue and not a criminal one.

We are pleased to see H.R. 7666 include provisions that reauthorize essential block grants and continue effective programs and initiatives. These will help our nation address the growing mental health and substance use challenges in all our communities. We also strongly support the proposed expansion of the reach of the federal requirement for parity in mental health and substance use services by eliminating the opt-out for non-federal governmental health plans.

## To further strengthen H.R.7666 we recommend the Committee consider adding the following to the legislative package:

 H.R.7116 - 9-8-8 Implementation Act of 2022, which would address 9-8-8 implementation more comprehensively. To ensure the successful 9-8-8 roll out we also recommend increasing funding to states for targeted outreach, education, and implementation, especially among marginalized

- communities so that all people, especially in areas of highest need, can access 9-8-8 and life-saving crisis services.
- H.R.4897 Support Recovery from Addiction Act of 2021, which would require a 10 percent setaside for recovery services. We also recommend a 10 percent increase in Substance Use Prevention, Treatment, and Recovery Services Block Grant funds to address the nation's growing overdose crisis. Investing in community based non-clinical services including recovery housing, recovery community organizations, peer recovery services, and other wraparound services is critical to helping people with addiction access the health and community supports they need to stay healthy.
- H.R.7233 Keeping Incarceration Discharges Streamlined for Children and Accommodating
   Resources in Education Act, which would require updated Medicaid guidance to states on billing
   for health services in schools and school-based health centers. Providing behavioral health
   services in schools is key to addressing our nation's youth mental health crisis and helps to reach
   students of color who may not have access in the community. Educating states about the
   existing opportunities to use Medicaid money for services in schools is an important step in
   growing these services.
- H.R.955 Medicaid Reentry Act of 2021, which would authorize Medicaid coverage of health services in the 30 days before an individual is released from incarceration. It is essential for people upon release to have uninterrupted access to the health services they need to stay alive and stay healthy; if more people were able to have continuous health coverage and access to life-saving addiction treatment through Medicaid during reentry, fewer people would die.
- H.R.1384 Mainstreaming Addiction Treatment Act of 2021, which would improve access to opioid use disorder treatment. Current restrictions on buprenorphine—an effective medication for opioid use disorder—require physicians to obtain a specific waiver in order to prescribe buprenorphine for addiction treatment. The MAT Act will remove the waiver requirement, making it easier for doctors to prescribe buprenorphine, help reduce racial inequities in treatment, and make it easier for all patients to access this life-saving medication.
- In order to meet the needs of the youth mental health crisis, we also recommend increased funding for evidence informed, non-punitive substance use prevention and early intervention services for youth.
