

**AMENDMENT TO THE AMENDMENT IN THE  
NATURE OF A SUBSTITUTE TO H.R. 6737  
OFFERED BY M\_\_\_\_.**

Page 1, before line 6, insert the following:

1       (a) MATCHING FUNDING REQUIREMENT.—Section  
2 2203(b) of the Water Infrastructure Improvements for the  
3 Nation Act (42 U.S.C. 300j–27(b)) is amended—

4           (1) by striking “The Secretary” and inserting  
5 the following:

6           “(1) IN GENERAL.—The Secretary”; and

7           (2) by adding at the end the following:

8           “(2) MATCHING FUNDS REQUIREMENT.—

9           “(A) IN GENERAL.—The Secretary may  
10 not award a grant or contract under paragraph  
11 (1) unless the applicant involved agrees, with  
12 respect to the costs to be incurred in carrying  
13 out the purpose described in such paragraph, to  
14 make available non-Federal contributions (in  
15 cash or in kind under subparagraph (B)) to de-  
16 fray such costs in an amount equal to not less  
17 than—

18           “(i) \$1 for each \$1 of Federal assist-  
19 ance provided through the grant or con-

1           tract for establishment of a lead expose  
2           registry; and

3           “(ii) \$3 for each \$1 of Federal assist-  
4           ance provided through the grant or con-  
5           tract for maintenance of a lead exposure  
6           registry.

7           “(B) DETERMINATION OF AMOUNT OF  
8           NON-FEDERAL CONTRIBUTION.—

9           “(i) DETERMINATION.—Non-Federal  
10          contributions required in subparagraph (A)  
11          may be in cash or in kind, made directly  
12          or through public or private donations,  
13          fairly evaluated, including equipment or  
14          services (and excluding indirect or over-  
15          head costs). Amounts provided by the Fed-  
16          eral Government, or services assisted or  
17          subsidized to any significant extent by the  
18          Federal Government, may not be included  
19          in determining the amount of such non-  
20          Federal contributions.

21          “(ii) SPECIAL RULE.—In making a  
22          determination of the amount of non-Fed-  
23          eral contributions for purposes of subpara-  
24          graph (A), the Secretary may include only  
25          non-Federal contributions in excess of the

1 average amount of non-Federal contribu-  
2 tions made by the applicant involved to-  
3 ward the purpose described in paragraph  
4 (1) for the 2-year period preceding the fis-  
5 cal year for which the applicant involved is  
6 applying to receive a grant or contract  
7 under such paragraph.”.

Page 1, line 6, strike “Section 2203(d)” and insert  
“(b) AUTHORIZATION OF APPROPRIATIONS.—Section  
2203(d)”.
