7 **FIREFIGHTER CANCER INCIDENCE.**

8 Section 2(h) of the Firefighter Cancer Registry Act  
9 of 2018 (42 U.S.C. 280e–5(h)) is amended by striking  
10 “\$2,500,000 for each of the fiscal years 2018 through

- 1 2022” and inserting “\$5,500,000 for each of fiscal years
- 2 2024 through 2028”.
