Bob Dix has served as the Vice President of Government Affairs & Critical Infrastructure Protection for Juniper Networks since 2006. During his career, he has served in senior leadership roles in industry and government, including serving as Staff Director for the House Government Reform Subcommittee on Technology, Information Policy, Intergovernmental Relations and the Census during the 108th Congress.

He represents Juniper as the Industry Executive Point of Contact for the President's National Security Telecommunications Advisory Committee (NSTAC). Mr. Dix was elected in May, 2011 as Chair of the Partnership for Critical Infrastructure Security (PCIS), and re-elected to succeeding terms in 2012 and again in 2013. He served as Chair of the Information Technology Sector Coordinating Council (IT SCC) from 2008 – 2010 and currently remains a member of the Executive Committee.
